It is currently only banned in cities, villages and in towns with population greater than 20,000. In addition, the revised rule will limit agricultural burning to naturally grown products such as vines, branches, leaves and stubble. It will also specifically allow such things as fire training, small cooking and camp fires, and ceremonial fires (e.g., proper disposal of U.S. flags by open burning). Finally, the revisions to Parts 215, 191, and 621 will eliminate the need for permits to conduct open burning that is allowed by Part 215.
