

The opening ceremony of the Town of New Baltimore's Bicentennial was held Sunday, March 13 beginning with a parade that included the Cornell Hook and Ladder Fire Company, the Greene County Sheriff's Office, Medway-Grapeville Fire Company, local scout troops, Civil War Reenactment and Revolutionary War Drum Line, veterans organizations, and Congressman Chris Gibson. Senator Jim Seward and Assemblyman Steve McLaughlin both highlighted the importance of small communities and the strong bond of families in their remarks before presenting legislative resolutions to Chair Joyce Schoenig and Supervisor Susan O'Rorke. Wayne Speenburgh, Chairman of the Greene County Legislature, also presented a proclamation with Legislator Jim VanSlyke and recognized the meaning of community and wondered if New Baltimore was formed from land that was "stolen" from Coxsackie. Congressman Chris Gibson thanked our local law enforcement officers, firefighters, youth organizations, and veterans for protecting our residents, providing hope for the future, and serving our country.

Twelve former Town Supervisors who together served our community for more than 40 years were recognized and Cliff Baldwin, Bill Finke, Nils Backlund, Bob Hallock, Ed Barber, and Dave Louis were present to accept special recognition.

Local resident Dick Brooks also read an original "Ode to New Baltimore" which documented the history of our town with help from local children who held pictures depicting our heritage of local industries like agriculture, shipbuilding, and ice harvesting.

The events of the day concluded at Town Hall, the former Rocky Store School, where many historical items and artifacts were displayed, refreshments were served, and conversations and friendships were enjoyed by all who attended the day's memorable community festivities.

### HISTORIAN'S CORNER

I am pleased to introduce myself in this space as the new Town Historian. We have been blessed with outstanding town historians over the last thirty-five or so years, namely Anthony Gambino, Walter and Frances Dietz, and Clesson Bush. With Cless, we actually got two for the price of one, as Jean is an outstanding historian as well. And so I have large shoes to fill. I am grateful to each of them, as I will be able to stand on their shoulders.

2011 is of course the bicentennial anniversary of New Baltimore's Declaration of Independence from Coxsackie, and I am fortunate that I have subject matter which is on everyone's mind. What we know about early town government comes from the hand written town minutes from 1811 – dutifully maintained under lock and key by our current town clerk Janet Brooks – and research done by Mrs. Dietz and published as Supplement #1 to the <u>Heritage of New</u> Baltimore.

Following the establishment of the town by the state legislature on March 15, the first town meeting was held on Tuesday, April 2, 1811 "at the house of Matthew Sitssers". The legislation creating the town actually designated the date and the location of the first town meeting "to be held at the dwelling house of Peter Wolf now occupied by Matthew Setts".

Mrs. Dietz argued convincingly that the Wolf/Sitssers house is the building still standing at the northeast corner of Route 51 and Roberts Hill Road. Early town records indicate Matthew

Sitssers was a tavern keeper in 1811. There were 190 men who voted that day for the first town office holders. It would be impossible for that many people to fit in the ground floor of that building at once, and still hard to believe that many would squeeze into two floors if an upper floor happened to be a dance hall. So men rotated in and out of the building to vote, which was done in a public or semi-public manner. The following were elected:

Town government business was minimal – in fact, there was no "town meeting" again for a year. There was no town board, so the business which was conducted must have been by consensus of those voters in attendance. No votes other than those for town offices are noted. The supervisor presumably chaired the meeting, and then was the legal representative of the town for purposes of entering into contracts and dealing with the state and other town governments whenever necessary until the next town meeting.

Elisha Hall went on to serve as town clerk until 1836. He would have been the face of local government during his tenure, just as town clerks are today in many rural upstate New York places.

No salaries are mentioned. The minutes reflect the need to raise \$150 for the operation of town government, but no budget is discussed.

A special thank you to Joyce and Jeff Schoenig and the Bicentennial Committee for their countless hours of planning for our successful 200 Years of Community celebration.

The only other topics of town business in 1811 were the welfare of the poor, management of livestock, and maintenance of roads.

We will look at these items in more detail in the next newsletter. On another note: the town has a terrific collection of historical photographs, many of which do not appear in the Heritage book and never see the light of day. As part of the bicentennial celebration, I am planning on making a presentation of the best of these photographs in the fall. If you have photos of New Baltimore people or places of years ago that are not in the Heritage book and would permit me to copy them and use them, please call me at 943-1060 (days) or 756-7647 (nights and weekends). 

GREENE COUNTY 2011 HOUSEHOLD HAZARDOUS WASTE COLLECTION EVENT

Greene County Solid Waste Management will hold its annual Household Hazardous Waste Collection Day for Greene County residents on Saturday,

June 25 at the Greene County Highway Department, 67 Scott Lane in Athens. This event is from 8 AM to 12 PM and residents are asked to arrive during suggested times according to the first letter of their last name. Proof of residency is required.

Household hazardous waste requires special handling, processing, and disposal and residents can ensure that these wastes are handled safely and recycled or disposed of properly.

Accepted materials are acids and bases, automotive fluids (except motor oil), chlorine, cleaning products, driveway sealer, fire extinguishers, fluorescent light bulbs, gasoline and kerosene, hobby chemicals and paints, paint removers and thinners, paints (oil and latex), pesticides/herbicides/insecticides, photo chemicals, swimming pool chemical, turpentine, varnish, weed killers, and wood preservatives and stains.

**Materials that are not accepted** are agricultural and commercial waste, compressed gasses (except aerosols), controlled substances, explosives and ammunition, fireworks and flares, industrial waste, infectious and biological waste, known dioxins, medical waste, prescription medication and syringes, radioactive materials, smoke detectors, and any non-household quantities.

Items that are not accepted but can be recycled normally include empty aerosol cans, motor oil, and propane tanks. Empty paint cans will not be accepted, but can be part of regular household waste.
