#### **2012 AG FEST June 2-3**

Free family fun begins at 9:00 AM for the 2012 New Baltimore Antique Machinery & Agricultural Festival on June 2 & 3 at the Van Etten Farm on Saw Mill Road. Activities include a children's tent with crafts, games and contests for all ages, including face painting, cake walks, and pie-eating contests. The agricultural displays will include a working steam tractor, a blacksmith, touch n go model planes, hit and miss engines, and horse & carriage rides. The Garden Tractor Pull is Saturday and the Antique Tractor Pull is Sunday. The New Baltimore Farmers Market will sell local products Saturday under the tent, including honey, perennials, and handmade wooded lawn sculptures. The Greene County Sheriff and Chase the K-9 dog will do a demonstration. The County Clerk, the Health Department, and Department for the Aging will have displays also. Presentations by Dean Davis our local reptile specialist, and Rochelle Ford's Falconry can be enjoyed by all. Music will include Steve Schwebler's One Man Band, Ralph Barger & Peaceful Country, Uncle Billy's Balladeers, and For God and Country. Food Vendors include Cornell Hook and Ladder and Frozen Desserts by Guido.

Saturday concludes with a Community Dinner -- for ALL residents of the town and vendors and exhibitors. Residents are asked to bring a covered dish to share; meat, potatoes and veggie are provided by the Committee. Albany Greene ATV Club provides security and handicapped transportation on site both days. The Silent Auction with over 100 items will be held all weekend, closing bids will end at 3:00 PM on Sunday.

The Ag Fest Committee looks forward to seeing a large turnout for the weekend events, fresh air, free entertainment and activities of historical agricultural nature are surely hard to come by these days, as the New Baltimore Antique Machinery and Agricultural Festival celebrates over 20 years of dedication to its cause.

## Greene Lodging and Waterpark Update

In February, the Greene County Legislature approved the bonds necessary for development and infrastructure improvements to support the water park and future expansion projects. Shortly after this action, Apollo Global Management made a tendered offer to purchase Great Wolf, which was initially accepted by its Board of Directors. A competing offer was made by KSL Capitol Partners, LLC and offers and counteroffers continued until Apollo made their final offer on April 20.

Apollo, a major investment group with over \$65 billion in assets, announced on May 4 that they have successfully completed the acquisition of Great Wolf, North America's largest family of indoor waterpark resorts. The IDA and MAR Holdings are watching and waiting during this process to see if Apollo will continue the expansion plans Great Wolf was implementing as well as the status of Great Wolf's management team.

Since MAR is unable to receive final commitments from potential investors until the process is finalized, the IDA has approved an extension until September 28 for meeting conditions in the Term Sheet and Option Agreement.

#### HISTORIAN'S CORNER

#### NINE THINGS YOU DIDN'T KNOW ABOUT NEW BALTIMORE HISTORY

People who spend time with history – researching, making connections between people and places, figuring things out – have an obligation to take the next step, which is writing. Writing requires you to crystallize rough ideas, organize disparate facts into a cohesive body. Ultimately, writing is an act of preservation, giving other people the benefit of what you know.

Writing is hard work – there are no short cuts to clarity and organization. It is also immensely time-consuming.

We are all the beneficiary of many hundreds of hours of time spent on local history by former town historian Clesson Bush. Cless's book <u>Episodes From a Hudson River Town</u>, was published last year by SUNY Press.

Historians like Doris Kearns Goodwin and David McCullough have achieved fame for their popular books by applying their wonderful story telling skills to familiar people and events. What Cless is doing is something very different. He has mined primary source documents, mostly newspapers and census records, for stories that have not been told anywhere and therefore would otherwise be lost. While scholarly, Episodes is also highly readable, not weighted down with heavy academic jargon or tone.

Here is my list of nine things you didn't know about New Baltimore history, taken from Cless's book – meaning of course nine things you may have known but I didn't.

## 9. Washington Avenue started out as the New Baltimore and Rensselaerville Turnpike.

The stories of the largest cities and smallest settlements, wherever you go, are the stories of transportation routes. Intersections of routes are even more important. The hamlet really started to grow when the turnpike from Rensselaerville was built to meet the Hudson River.

The other two major routes for most of town history, County Route 61/Route 144 to Albany and County Route 26, also started out as turnpikes, or toll roads built by private citizens.

8. There were once seventeen school districts in the Town of New Baltimore.

All of them were considered to be one room school houses except the hamlet school.

Each district had its own school board, which hired the teacher. All students walked to school. The districts consolidated, one by one, until the day came when the remaining schools consolidated into districts headquartered in neighboring towns, and New Baltimore has no public schools today. (There are numerous former schools still standing in the town. Do you know where they are?)

This is how consolidation took place: the state would propose a central ldistrict, the boundaries set by the state, and there would be a vote, but ...

### 7. One vote was held across the entire proposed central district.

So if the state proposed a central district to be created from existing Districts 1, 2, 3, 4, and 5, the consolidation would take place if a majority of voters in the five districts said so. The majority of the voters in District 1 could vote overwhelmingly against the proposal, but they would be swept along against their will by the majority of voters in the other districts. This doesn't seem fair.

- 6. One of the advertised selling points in favor of consolidation was that school taxes would go down!!!!
- 5. There was great spontaneous celebration on the streets of our little downtown when the Armistice ending WWI was announced.

"The fire bell in the hamlet began to ring in triumph", Cless writes, "joined quickly by the chiming bells at the Reformed and Methodist Churches and the one atop the brick school building... at seven in the evening, a couple of hundred joyful citizens gathered at the intersection of Main and Mill Streets. Fronted by Uncle Sam, the Cornet Band and Nickle's Drum Corps, the energetic crowd marched through the streets proudly flying American flags..."

Cless paints a great picture of the very active downtown during the shipyard era – stores, hotels, fire house, post office, churches, school. Alas, there is also a lively discussion of the Great Fire of 1929.

### 4. New Baltimore was dry before the country.

What those end-of-the-war celebrants could not do was raise a glass of beer. What Cless calls "the temperance gang" had successfully outlawed the licensing of alcohol sales in town in 1917.

# 3. There was a riot and a confrontation between striking railroad workers and local police during the construction of the West Shore Railroad in 1882.

Sheriff Churchill must have eventually tamed the mob of three hundred workers, who wanted to be paid \$1.50 a day instead of \$1.35.

The newspaper reported on a different occasion that year that the streets of New Baltimore were "thronged Sunday with Italian laborers," who were "quiet and orderly."

# 2. There have been two newspapers published in the town, the New Baltimore Globe and the New Baltimore Sun.

Coincidentally, the Baltimore Sun is today one of the best newspapers in the United States.

## 1. In 1939 there were eighty-eight fruit farms in town; just ten years later there were forty-seven.

As Cless says, "Agriculture's history in New Baltimore is really the history of the town". It is startling how the number of farms diminished in a relatively short time. WWII was a major factor in this decline. Surely some farms closed because the work force was in the military. After the war, the GI Bill and the demands on manufacturing sent would-be farmers in other career directions.

Clesson does a nice job putting the events here in town in the context of larger national and international events and trends, which is what a "local historian" must do if he or she is going to be more than just a fountain of local trivia. Mentioned alongside Henry Hudson and Robert E. Lee and Thomas E. Dewey are Nils Backlund, Fran Williams, Walter Dietz and Cliff Armstrong, just as it should be in this kind of book.

It's a lot of fun, just as history should be. You can get a copy of <u>Episodes</u> from your favorite bookseller or by calling Cless.

The Annual Household Hazardous Waste Collection Day for Greene County residents is scheduled for Saturday, June 23 at the Greene County Highway Department, 67 Scott Lane in Athens. The event, sponsored by Greene County Solid Waste Management, will be held from 8 AM to 12 PM and residents are asked to arrive at the suggested time according to the first letter of their last name. Proof of residency is required.

Household Hazardous Waste is a household quantity of a product that is toxic, should not be disposed of as everyday trash, and requires special handling, processing, and disposal.

Accepted materials are acids and bases, automotive fluids (except motor oil), chlorine, cleaning products, driveway sealer, fire extinguishers, fluorescent light bulbs, gasoline and kerosene, hobby chemicals and paints, paint removers and thinners, paints (oil and latex), pesticides/herbicides/insecticides, photo chemicals, swimming pool chemicals, turpentine, varnish, weed killers, and wood preservatives and stains. Materials that are not accepted are agricultural and commercial waste, compressed gasses except aerosols), controlled substances, explosives and ammunition, fireworks and flares, industrial waste, infectious and biological waste, known dioxins, medical waste, prescription medication and syringes, radioactive materials, smoke detectors, and any non-household quantities.

Some items that are not accepted but can be recycled normally include empty aerosol cans, motor oil, and propane tanks. Empty paint cans will be not accepted, but can be part of regular household waste. Residents can call 943-4600 or email solidwaste@discovergreene.com with questions.

#### WHAT HAPPENS WHEN YOU DIAL 911?

An emergency occurs in Greene County — a traffic accident, medical condition, a weather situation, or a fire — and a 911 call is made. Did you ever wonder what happens next?

That call is sent to a dispatcher at the Greene County EMS Center in Cairo, which has been in operation for over seven years. There are two or three dispatchers per shift, three shifts each day. The Dispatcher answers the call, and asks a series of questions called the Emergency Medical Dispatch Protocol Reference System and enters the information on a CAD screen. Many questions are asked to determine exactly what happened and which emergency services are needed (Fire, EMS, or police) and to pinpoint the exact location of the emergency so the correct county, town, or village emergency apparatus can be dispatched to the scene. They currently dispatch 28 fire companies and 12 EMS, Greene County Sheriff, State Police, and 6 town police agencies. Dispatchers are trained to ask many questions to gather as much information as possible to get the proper assistance needed for the situation.



Sometimes their days are long and stressful, but the most satisfying part of their job is when they can help someone in need and save lives.

There were many long and stressful days during Hurricane Irene and they worked together and with other agencies to assist thousands of residents and business owners. According to Randy Ormerod, Deputy Director of Emergency Services, there were 49,125 calls in 2011 for service, an average of 135 calls a day. Between August 28 and August 31, during Hurricane Irene, there were 4,633 calls, some of which were rolled over to another county due to the volume of calls received and the number of dispatchers available.

The Dispatchers have offered some helpful tips for travelers. When driving out-of-state, be aware of landmarks, towns, or what road travelers are on when reporting an emergency which helps to locate them quicker. Keep cell phones and area codes updated. While they are happy to assist when needed, not everything is an emergency and sometimes other agencies, like Central Hudson for power outages, should be called first.

Special appreciation to Jamie Davis, a dispatcher for the 911 Center for the last two years, resident of New Baltimore, and member of Cornell Hook and Ladder Fire Company for arranging a tour of the 911 Dispatch Center and interview with the Dispatchers and Randy Ormerod . Jamie is a member of the National Guard 109th Security Forces and was deployed on March 31 for a six month tour of duty overseas. We appreciate her service and wish her a safe and quick return. The Dispatchers will miss her!

If a weather or urgent situation occurs, a message will be sent by telephone, email, or text message. Depending on the emergency, warning messages can be send to all county residents, certain towns or villages, or a single road.
