Supervisor Dellisanti opened the Public Hearing at 6:00 PM. Also attending Deputy Supervisor Ruso, Councilmembers Briody, Irving, and VanEtten, Tal Rappleyea, Esq., Town Clerk Finke, Tax Collector Jordan, and 2 members of the public who signed the attendance book. Absent: Highway Superintendent Jordan

**Supervisor Dellisanti** read, "Town of New Baltimore Greene County, New York Notice of Public Hearing on the Proposed New Comprehensive Plan Please take Notice that the Comprehensive Plan Committee of the Town of New Baltimore shall hold a public hearing on October 24, 2016 at 6:00 pm in the evening at the Town Hall, 3809 County Route 51, Hannacroix, New York 12087, to accept public comment on the proposed new Comprehensive Plan. Copies of the Plan are available in the Town Clerk's office. By order of the Comprehensive Plan Committee."

If for any reason you as a landowner or farmer with over 100 acres wants to set aside 50 percent of your property, you have every right to do that, but you are no longer mandated to do that. That's the distinction that the Committee has made. Tonight we have Bill Albright and Kathy Rundberg with us that were on the Committee. I want to thank them for their tireless work. This Committee met as I mentioned at the previous meeting one Wednesday of each month for the last two, two-and-a-half years. A lot of time and effort went into this and I thank them immensely for all their efforts.

**Tal Rappleyea, Esq.**: Each one of those meetings were open to the public and essentially were Public Hearings, but we felt in the abundance of caution that we should have this also final wrap-up Public Hearing.

**Rich Guthrie**: What is the status of the Plan in terms of adoption or proposed adoption and additionally is there a comment period extended beyond tonight's Public Hearing?

Supervisor Dellisanti: I think we're finished tonight.

**Councilmember VanEtten**: We're finished tonight. We've already had one; this will be the second one. We got all positive comments at the last one, so I think we're finished tonight. It's a 50 percent set-aside only.

**Rich Guthrie**: So the usual two week comment period for written comments after a Public Hearing, is that not available this evening?

**Councilmember VanEtten**: The Public Hearing was at the last meeting on the 50 percent setaside.

**Councilmember VanEtten**: That's going to be at the next Public Hearing that will be in November on that.

Alta Turner: That will be in November?

Councilmember VanEtten: November 14 I think it is.

**Supervisor Dellisanti**: That's correct. We are going to announce that tonight in a resolution so it will be put in the newspaper also on the website for the  $14^{th}$  of November.

Alta Turner: And where, I presume they'll be some kind of maps.
