Supervisor Dellisanti: Notice of Public Hearing on Local Law 3 of 2017 'Notice is hereby given that there will be a Public Hearing on November 13, 2017 at 7:00 PM at the Town Hall to accept public comment on the proposed local law providing for continuance of the real property tax exemption for Cold War veterans. By Order of the Town Board Barbara M. Finke Town Clerk"

WHEREAS, Section 458-b of the Real Property Tax Law which authorizes a limited exemption from real property taxes for residential real property owned by veterans who rendered military service to the United States during the "Cold War" is set to expire; and

WHEREAS, an amendment to said Real Property Tax Law 458-b effective September 17, 2017 authorizes municipalities to continue the real property tax exemption upon the enactment of local law authorizing same; and

WHEREAS, in regard to "Cold War" veterans who own residential real property within the Town of New Baltimore, it is the desire of the New Baltimore Town Board to continue to offer the "Cold War" veterans exemption at the maximum amounts;

LOCAL LAW 3 OF 2017

SECTION 1. In accordance with the provisions of Section 458-b and amendments thereto, of the Real Property Law of the State of New York, residential real property owned by veterans who rendered military service to the United States during the "Cold War" shall be partially exempt from town taxation.

SECTON 2. The maximum exemptions allowable from town real property taxation pursuant to Section 458-b of the Real Property Tax Law are hereby adopted.

SECTION 3. This local law shall take effect immediately upon its filing with the Secretary of State.

Anne Mitchell: So what are the maximum limits?

Supervisor Dellisanti: That's a good question. I honestly don't know the limits, but according to the Assessor they would be the same as they were in the previous era. It's a percentage. I don't know what the formula is, but it's the exact same formula as they used before.

Anne Mitchell: So this is similar to, I was on the school board for a long time and there were veterans' property tax exemptions, but they...

Supervisor Dellisanti: This is specifically for the Cold War.

Anne Mitchell: No, no, I understand, but we always followed what the County amounts were so that it wasn't different among all the different towns.
