\$29,500.00-\$30,399.99	30%
\$30,400.00-\$31,299.99	25%
\$31,300.00-\$32,199.99	20%
\$32,200.00-\$33,099.99	15%
\$33,100.00-\$33,999.99	10%
\$34,000.00-\$34,899.99	5%

It's my understanding that this is done every two years.
