TOWN OF NEW BALTIMORE NOTICE OF JOINT SPECIAL BOARD MEETING

Notice is hereby given that the New Baltimore Town Board will hold a Joint Special Meeting on Tuesday, November 27, 2012 at 7:00 pm at the Coxsackie Town Hall, 16 Reed Street, Coxsackie, NY 12051.

The purpose of this Joint Special Meeting will be a joint meeting of the Town of Coxsackie Town Board and the Town of New Baltimore Town Board regarding the land annexation by New Baltimore of 4 vacant acres in front of Empire Merchants in Kalkberg Commerce Park that straddles the towns' lines as well as the annexation by Town of Coxsackie of 9 acres that have been assessed in the past by Town of Coxsackie, and the deeds for which all indicate Town of Coxsackie, located at 12319 US 9W in the Town of New Baltimore. This notice is in accordance with General Municipal Law section 703-a.

By Order of the Town Board Janet A. Brooks Town Clerk

Town Supervisor Betke reviewed that the purpose of the meeting is to discuss the annexations: a swap of land along US Route 9W corridor between Town of Coxsackie and Town of New Baltimore to resolve a longstanding issue of boundary line and regarding tax rolls. Having reached an amicable solution, Supervisor Betke related that his grandfather, as mayor, had dealt with these issues in the 1960's. Supervisor Betke reminded, first, to look at and formalize the agreement to move forward with shift of a triangle, split by town boundary and requiring negotiations with how businesses may come into business park, on east side of US Route 9W to Town of New Baltimore. The pump station's precise location was also discussed. Second, to work out well, we have proposal that Diederich's/Slater family's roughly-9acre parcel in question will stay in Town of Coxsackie; Supervisor Betke conferred with Slater family who desire to stay in Town of Coxsackie. To resolve this issue, Supervisor Betke said the Town of Coxsackie will relinquish the Greene IDA about 2-acre (4 acres altogether) parcel along Town' boundary in Kalkberg Commerce Park.

Supervisor O'Rorke thanked Supervisor Betke for his description and the members of the Town Board of Town of Coxsackie for working with Town Board of Town of New Baltimore, with appreciation of their cooperation to move forward on this.

Supervisor Betke asked for questions from the Boards. Hearing none, he asked for questions from the public. Hearing none, he suggests setting public hearing; discussion ensued regarding 20-day window and dates; to hold this in December provides for it to be on the tax rolls for January 2013.
