**RESOLUTION TO AUTHORIZE THE SUPERVISOR TO SIGN AN
ADDENDUM WITH THE VILLAGE OF COXSACKIE TO CHANGE TO

WHEREAS the Village of Coxsackie and the Town of New Baltimore entered into an agreement on May 14, 1974, with an extension on March 16, 2005, to provide water to residents in Scheller Park,

WHEREAS the Village of Coxsackie wishes to coordinate the quarterly billing cycles of the Town of New Baltimore and the Village and Town of Coxsackie

NOW, THEREFORE, BE IT RESOLVED that the Supervisor of the Town of New Baltimore is authorized to sign an addendum to change the water agreement by moving from biannual to quarterly billings and allow the Village of Coxsackie to bill for water service in January, April, July, and October.
