**RESOLUTION TO ADOPT SUPERVISOR'S 2013 ANNUAL FINANCIAL REPORT
UPDATE DOCUMENT SUBMITTED TO THE STATE COMPTROLLER AND ON
FILE IN THE TOWN CLERK'S OFFICE FOR PUBLIC INSPECTION**

WHEREAS New York State law requires that the Supervisor shall submit to the Town Clerk, within ninety (90) days after the close of the fiscal year, a copy of the Annual Financial Report to the State Comptroller, and that the Town Clerk shall place a notice that the report is on file in the Office of the Town Clerk, to be so published within ten (10) days after receipt thereof, in a form approved by the State Comptroller, and in the official newspaper of the Town of New Baltimore.

IT IS HEREBY RESOLVED, that the Town Bookkeeper has completed such Report, submitted same to the New York State Comptroller and that the Town Board has reviewed and hereby accepts and approves such Report, and it is further
