**OPENING REGULAR TOWN BOARD MEETING**

Supervisor Dellisanti called the meeting to order at 7:09 PM and the Pledge of Allegiance was said. Also attending: Councilwomen Benway and VanEtten, Councilman Norris, Attorney for the Town Tal Rappleyea, Town Clerk Finke, Tax Collector Jordan, Highway Superintendent Jordan, and 15 members of the public who signed the attendance sheet.

Absent: Councilman Ruso

**Supervisor Dellisanti** observed you might notice that we have some new camera equipment that was donated by MH cable. This is our first endeavor. We will be taping tonight and if anyone does have a question during the Public Comment Period, please go over to the podium so we can get that on the tape as well. Eventually in January we are hoping to get this on MH Cable so if you are unable to make our Town Board meeting, it will played on MH Cable, I think Channel 11 if I'm not mistaken. And you will be able to see what actually took place here. We have opening bids for a surplus generator and paving materials.

**OPENING BIDS FOR SURPLUS GENERATOR AND PAVING MATERIALS**

**Town Clerk Finke** reported that one bid was received on the generator, Robert VanEtten Excavating for \$2,575.

**Supervisor Dellisanti** pointed out he discussed with our Highway Superintendent and he had given us an estimate from about \$1,000-\$1,500. I also wrote Brock Juusola a note asking him what he thought the material was worth and he said it was worth approximately \$1,000 so this is a good bidder. We will discuss that as we get to the resolutions. Did you get a bid on the paving materials?

**Town Clerk Finke** reported there are two bids for paving materials. The first is from Callanan for \$59.44/ton installed and the second from Peckham Road Corporation for \$61.46/ton.

**Supervisor Dellisanti** explained we will discuss this further when we get to the resolutions and I will let you make some comments on it as well, Denis.

**PUBLIC COMMENT PERIOD**

**Richard Guthrie** began I just want to bring to the attention to the Board and neighbors, especially those who are not in the Hamlet or live down by the River and I don't want to make this not in the form of a complaint, but as an observation so that at least you know. The Corps of Engineers is in Town. If you have not witnessed a new industrial facility in the Town of New Baltimore, I invite you down to the River where we have a 24/7 operation going on down there with a big barge going up and down the River and various utility boats zooming back and forth and the best of all is the stadium lights that light up the River from shore-to-shore and bank-to-bank for a mile up and down the River. It transforms the nature of a moonrise over the River for the benefit of those folks who are down there. Again this is not a complaint, they are doing what they need to do. However, I think it is going to be something that is going to be recurring from year to year. It is not the same as it use to be. They used to tiptoe in, get the job done, and move out and all well and good. Now they are here with a vengeance. and they have super modern huge equipment with big rigs operating on the island which is part of the Town of New Baltimore with big pay loaders and backup beepers going on again throughout the night 7 days a week. When they knock on the door next time around, I think and I believe now Barbara informs me that we are on their list to be informed when they are proposed to come into Town, that we at least know that. I had to call them up and talk to them about their contractor boats that

were as I said ripping up and down the River creating destructive wake unnecessarily. The time to get from Shady Harbor Marina to the operation is not all that long, they just slow down, reduce the wake, and reduce their impact on the shoreline would be much appreciated. I have to give them credit, they went right to work on it, the boats slowed down right away and now they go by gently and all is well for the time being. Again not a complaint, they have got to do what they got to do. We like the Hudson River, we like the navigation, we like to see the business and jobs and opportunities that it brings and this is part of that payback that they have to take with them. Just to share what we are now experiencing down there. They will be done by the time the ice forms up I presume and then it will be another year or longer before they are back.

**Councilwoman Benway** questioned on the Peckham quote, it says it is only good for 30 days?

**Highway Superintendent Jordan** explained this quote, whoever gets it, it goes for one year.

**Councilwoman Benway** asked so if we accepted it, but didn't do it until...

**Highway Superintendent Jordan** answered we are not doing it until May.

**Councilwoman Benway** continued or August, or let's say sometime next year obviously...

**Highway Superintendent Jordan** explained I want to do it first thing in the spring or May, that's what I told them both.

**Councilwoman Benway** continued if Callanan if they came in at the 3,550 tons as well....

**Highway Superintendent Jordan** pointed out we don't care about that, it's in place, the ton in place. That's what we are going for because every year it is less tonnage than what they quote even though they are putting it two inches, they add 20 percent, I don't know what they do.

**Councilwoman Benway** asked they both do that?

**Highway Superintendent Jordan** responded yes.

**Councilwoman VanEtten** noted so for the Callanan quote, that's just an estimated amount of asphalt, whatever they lay is what we pay for.

**Highway Superintendent Jordan** answered right, that's why I was going in place per ton which is Callanan.

**Councilwoman Benway** described for \$59.44, they are cheaper per ton.

**Highway Superintendent Jordan** replied right. last year it was done at \$58.40, so that's a good price, still with 10% RAP which I required so this is a very good price.

**Supervisor Dellisanti** remarked so what you are saying is even though the two companies, one bid 3,500 tons and one bid 3,350 tons, they may not even come close to using that.

**Highway Superintendent Jordan** answered correct, exactly.

**Superintendent Dellisanti** clarified so you are saying that the \$59.44 is the better deal.

**Highway Superintendent Jordan** answered because we may not decide to spend the \$205...

**Supervisor Dellisanti** stated \$205,000....

**Highway Superintendent Jordan** continued if we only got \$160,000, we want to know what is it going to cost us in place. We are going to go until our \$140,000 or \$160,000, that's where we stop. Just like Roberts Hill, we couldn't do the whole thing because we didn't have enough money so you don't know how much it is going to be until you get the price from these people what it is per ton in place. So we have to give them a bunch of roads, not necessarily means that you are going to get them all done. Now you and I and the Highway Committee have to sit down and we have to go over how much we are going to spend next year on blacktop besides the CHIPS money.

**Supervisor Dellisanti** added on top of the CHIPS money.

**Highway Superintendent Jordan** responded yes exactly, correct.

**Councilwoman Benway** commented so the \$59.40 is still...

**Highway Superintendent Jordan** agreed that's what we want, not the 35 or the 33.

**Councilman Norris** noted so if we accept that bid, we are locked into that price?

**Highway Superintendent Jordan** answered yes.

**Councilman Norris** asked are the prices going to come down because we see gas prices coming down?

**Highway Superintendent Jordan** explained well that's why we've discussed it, because I've see it going down because it was \$68.

**Supervisor Dellisanti** clarified that's why we are doing it now.

**Highway Superintendent Jordan** agreed it's come down that much, so this is a good price, if it comes down more..

**Councilman Norris** added that' what I'm saying, is it actually going to come down more?

**Councilwoman Benway** continued but if they are wrong...

**Supervisor Dellisanti** noted last year it was \$58 something.

**Highway Superintendent Jordan** answered \$58.40.

**Supervisor Dellisanti** noted that's not terrible.

**Highway Superintendent Jordan** said I expected higher honestly, that's quite a bit, it was \$10.

**Supervisor Dellisanti** asked any comments? I'm just concerned about the tonnage. We are not dealing with apples to apples. My only question was the tonnage 3,500 to 3,350.

**Councilman Norris** reported it does say estimated on the Callanan bid.

**Councilwoman Benway** suggested if they come in less, then they will charge us for the less.

**Highway Superintendent Jordan** explained we have to do it by the ton, like I said. We can't go by their estimate, we have to go with what they put down. I get the slips from the truck driver, so we decide how much they are putting down.

**Supervisor Dellisanti** clarified so you can stop at any time basically.

**Highway Superintendent Jordan** agreed I can stop at any time correct. We are not locked in at 3,300 or 3,500, it is the amount that we what to spend, and I told them that. But they don't tell me what they are going to bid on it. We have to give them more than what we are actually going to spend so we know.

**Supervisor Dellisanti** noted the details are included; this is for all employees and elected officials. This is what will be submitted. You will note that the Social Security numbers and Registration Numbers have been omitted, but that will be on the final document that's sent to the Retirement System. These numbers have all been submitted by the employees and/or elected officials, they ascertained it and they also have to defend it when they go for their Retirement.

**Councilman Norris** asked does this include everybody in the Town?

**Supervisor Dellisanti** answered anyone that has elected to be in the Retirement System.

**Councilwoman VanEtten** added some people opted out.

**Town Clerk Finke** pointed out and you contacted a number of times and this is all that got back to you.

**Councilwoman VanEtten** explained I was told when I called, if you contacted them and they didn't submit anything, then you can fill out the report and just not include them because it is up to them to get the information in.

**Supervisor Dellisanti** noted we received a letter from the Retirement System saying this wasn't done in 2013. I got this letter I guess it was October and we have been putting this together ever since.

**Councilman Norris** asked so anybody who is in the Retirement System needs to do this. If you are in the Retirement System you need to do this?

**Supervisor Dellisanti** answered you and I don't have to do this, you are not in the Retirement System.

**Councilwoman VanEtten** added unless you are retired.

**Councilman Norris** noted I just see some names that are not on there.
