#### **OPENING OF REGULAR MEETING**

Supervisor Dellisanti opened the meeting at 7:00 PM and the Pledge of Allegiance was said. Also attending Deputy Supervisor Ruso, Councilmembers Briody, Irving, and VanEtten, Town Clerk Finke, Tax Collector Jordan, and 5 members of the public who signed the attendance book. Absent: Highway Superintendent Jordan

**PRESENTATION BY MARY BETH BIANCONI FROM DELAWARE ENGINEERING Supervisor Dellisanti:** Thank you. We have a presentation tonight, a brief presentation by Mary Beth Bianconi from Delaware Engineering.

Mary Beth Bianconi: It is a brief presentation and it's a good presentation. The kind everybody likes, it's about free money. This is your money that you need to go get back instead of it going to some other community. We have our Wastewater project, now been working on for several years. As folks know we're working towards closing on a 0% interest loan for the project. In the past there was this program called New York State Water grants. We did not qualify for that program in the past. We either would have had to have a very low income, we would have had to have sewage spills, or we would have had to been affected by Hurricane Irene or having our treatment plan flooded or something like that to qualify. Just in May, literally just recently, the State expanded the program and we qualify for the grant now. So what you have is the grant application in front of you. The way that this program works, it's not a bag of money, that would be nice, but this would be if our project has a certain cost, we would go borrow that money on a short-term basis, construct our project. When we went to close on the long-term borrowing, which is what will result in that 30 year, 0% interest loan, they will give us what's called Principal Forgiveness. So say we spent \$2 million and they gave us a \$.5 million grant, we would only close on a loan \$1.5 million, so that's a direct reduction in what people pay for the project over time. So that's how they do it without actually having any cash on hand. It's not a bag of money.

Supervisor Dellisanti: It's all paper.

Mary Beth Bianconi: It's just paper. So I just really quickly wanted to tell you that's very good news for us that we do qualify, obviously there's no guarantees. We also don't know exactly when they are going to announce these grants. The due date isn't until June 20, although they're encouraging as early an application as possible. You were all ready to go, all we had to do was put together this little tiny packet because of the work we did back in March. That's what got us all cued up for this. So what you have is the grant application. One of the things that's interesting about this is you'll note it doesn't actually ask for any particular dollar figure. It does list your total project cost which is \$2.61 million. That is because the grants are offered on a sliding scale and they will let us know if we qualify for the grant. If you qualify for a state grant, they give us the grant, they'll let us know how much they're going to give us. So all we really need is the Supervisor's signature on this sheet of paper and we will send this in tomorrow.

**Supervisor Dellisanti**: Excellent. Just as a bottom line, this is going to lower the annual rate of for every homeowner in the Hamlet.

**Mary Beth Bianconi**: That's right, that's how it works. Just remember what people are paying in their sewer rates is a combination of the cost of operating and maintaining the system and pay back debt service. And the debt service is a fair chunk of the cost that we have. This would reduce that debt service portion for everybody because again if we're going to spend \$2.6 million and say they gave us \$600,000 in grants, we would only borrow \$2 million.

**Supervisor Dellisanti**: That's great, that's excellent. I am going to make a Motion that the Board allows me to sign this application so Mary Beth from Delaware Engineering can put the grant application in for approval, seconded by Councilmember VanEtten.

**Mary Beth Bianconi:** These are digital submissions, we put them on a pdf form and we click the button. It's very undramatic these days. This is the submission that's being sent in so you

have a record copy. As Nick knows all too well, you will now subsequently get dozens of emails with all kinds of confusing stuff. We get copied on those.

**Supervisor Dellisanti:** Which I send you anyway.

**Mary Beth Bianconi**: Does anybody have any questions?

Supervisor Dellisanti: No, this is great. Thank you, Mary Beth.

Mary Beth Bianconi: Thank you, congratulations.

Councilmember Ruso: When will we know?

Mary Beth Bianconi: June is when they're due. We're thinking that they're going to have to tell people whether they're getting grants or not before October 1. The reason that we say that is that's the start of the next federal fiscal year and so for people who are applying for these grants who are further on in the process, so they have already gone out to construction, they might be building their project now and getting ready to close on that long-term borrowing sometime soon, they will need to know if they're going to have a grant. So we're thinking that that's the timeframe although we can search high and low when and there isn't anything anywhere that tells you exactly when they're going to let us know. But the applications are due June 20. There were already applications due for this back on May 15 and on May17 which was a Monday, they sent out a notice saying now they're due on June 20 and they expanded the application criteria which worked out well for us. Jeff, as soon as we know anything we will certainly let you know.

#### Fire, EMS, and Law Enforcement Greene County EMS

Dear Mr. Dellisanti: I am pleased to inform you that the above referenced property was listed <a href="April 26, 2016">April 26, 2016</a> on the National Register of Historic Places. As you may know, the National Register is the nation's official list of properties worthy of preservation. Listing on the National Register recognizes the importance of these properties to the history of our country and provides them with a measure of protection. In addition, owners of income producing properties may qualify for federal and/or state income tax benefits. Homeowners in qualifying census tracts may qualify for state income tax benefits for approved work. Properties owned by municipalities and not-for-profit organizations are eligible to apply for state historic preservation matching grants.

#### County Legislator

May have been another busy month. I attended the standing committee meetings, the regular legislative meeting, and 3 additional GC Jail Task Force committee meetings. We have a conceptual design, which will see revisions still, and hope to interview construction management firms shortly. The Ambulance Task Force has opted to run some numbers with 2 different scenarios and will meet again in July to go through them. As May is Greene County Older Americans Month, we awarded several Commendations and Certificates of Merit to seniors throughout the County at the regular Legislative meeting. There is a new Greene County Transit System beginning June 1, 2016. This system is a collaborative effort between Greene County, NYS, and Ulster-Greene ARC. By partnering together to offer increased services, with the consolidation efforts with the Governor who wants the towns and everyone to start doing this, we were able to receive funding for 7 new handicap accessible busses. These busses will hold 14 passengers and 2 wheelchairs, or 18 passengers. There will be 5 routes daily to Catskill, plus Hunter on Wednesday, and Windham on Friday. The one-way trip cost for any route will be \$3.00, and the Catskill Shuttle will cost \$2.00. Anyone who pays to ride one of the routes will be able to ride the shuttle at no additional cost. The ARC website will have more information, as well as a number to call for comments. The system will evolve based on comments received.

**Ellie Alfeld**: That bus has been running on my road for over two weeks now. We didn't know what it was. It's just got two initials, GC, and thought it was, we have a disabled person at the end of the road and originally the Center for the Disabled was picking up every day. Then all of a sudden this bus appeared. We had no idea what it was. I'm glad but I hope a lot of people find out about it.

Councilmember Ruso: I've seen this bus as well and I didn't know what it was.

**County Legislator Linger**: They are literally brand new and there were a couple of busses that were on their way out.

**Ellie Alfeld**: I can tell you they are right on time, 7:00 in the morning and 5:00 at night. They pick up at 7 and drop off at 5 on my road.

County Legislator Linger: And they will stop if you are out on the route and you flag them down, it will stop and pick you up. I do have a folder that they gave me with some limited information if anybody wants to take a look at it. Right now it's a start for a Countywide transit system which we don't have. So it's a place to start and now going forward it is going to be based on what the need is. There is going to be one bus a week that goes to Hunter, one bus a week that goes to Windham right now.

**Councilmember Briody**: You have the busses distributed, is that what you are saying, across all the different towns?

County Legislator Linger: They are all based out of Catskill.

**Councilmember Briody**: But the bus that comes through here, it has to go down and it will come back so it will pick people up at different times.

**County Legislator Linger**: There's actually a schedule in here.

Councilmember Briody: That's awesome; that's a great idea.

**County Legislature Linger**: They will go to your house if you need them to go to a house, just call ahead of time and let them know, but they will go off the route. It's a start, but it's a really good start.

Councilmember Irving: Is that seven days, Pat?

County Legislator Linger: I believe it's five days. Monday through Friday. I attended the Cornell Hook & Ladder installation dinner, where I presented Legislative Commendation to Jack Wallace for his 60 years of active membership. The fire company is scheduling a special meeting to award another 60 year award to Bill Finke, as he was out of town. They're both 60 years this year and they're both still active every week on calls. That's pretty impressive. The Stanton Hill Cemetery which was listed on the NYS Register of Historic Places, has now been awarded listing on the National Register as well. The Thomas Cole Studio in Catskill has been reconstructed and is open to the public. Thomas Hoyt of Maplecrest, Town of Windham, has been appointed to succeed Bob VanValkenburg as Deputy County Highway Director. Notable resolutions approved this month: -Bid awarded for the replacement of the Hunter Emergency Services Tower, -Fuel Oil bids awarded 6/1/16 - 5/31/17 Towns will be able to piggyback on this bid at \$1.27 per gallon, -Washed and Crushed stone bid awarded 5/22/16 - 5/21/17, -Quick quotes awarded for paving county roads, including CR 61 from Kings Rd to Cole Ln, a distance of 1.23 miles, at a cost of \$50.02 per ton installed, -Authorization of Distribution of Mortgage Tax, \$47,524.88 to the Town, -Authorized the purchase of a used dump truck - Highway Dept, -Authorized the purchase of 3 new vehicles - Sheriff's Dept. In addition to all that, I have 2 Wayne C. Speenburgh Legislative Grants to present this month. The first I presented on May 21st to the New Baltimore Reformed Church and Fran Matalon-Degni. This grant will help defray the costs associated with the "It's Elementary" program, a documentary of days gone by at the New Baltimore Schoolhouse. This program will move throughout the county and neighboring communities, before finally residing in the Vedder Library in both book and digital recording forms. The second grant I will present tonight to Shelly VanEtten and the Town of

New Baltimore. This grant will help fund the children's park program. It will help support the roughly 30 families who send children to our park for summer fun and education. With these grants presented, this will bring the total so far this year to \$8,000 that has been brought to our Town to support various groups.

I attended the New York State Town Clerks Association Annual Conference on Saratoga from April 17-20. I attended educational session from Sunday through Wednesday on Business Automation Systems, Diversity, Birth/Death/Marriage Certificates, Overview with the Association of Towns, Town Clerk Basics, Minutes, Cyber Security, Freedom of Information and Open Meetings Law, and the Opening Ceremony and Business Meeting. In the Columbia Greene Town Clerks Association, there were three new Town Clerks attending -- Bonnie Poehmel from Windham, Tistrya Houghtaling from New Lebanon and me. We carried in the banner at the Opening Ceremony. It has been customary for the banner to be on display at one of the new Town Clerk's Town Halls and I was asked if the Town of New Baltimore would be interested. The banner will shortly be on display. We also were recognized for the Most Spirit at the Mixer. Again, the only reimbursement I asked for the Registration Fee of \$125.

I received one new FOIL which has been satisfied. The one remaining FOIL has been completed was reviewed today by the requestor following notification by letter dated April 1. In total 120 staff hours were expended and an additional 1.75 hours with Tal Rappleyea, Attorney for the Town with an estimated cost of \$1,882. The requestor asked for 24 copies, for a total reimbursed to the Town of New Baltimore \$6. (Pointing to two large stacks) And this is the response to this FOIL.

Ellie Alfeld: I just caught that when I read the Minutes of that meeting; I wanted to make sure it was correct.

**Supervisor Dellisanti**: That's what Civil Service has categorized that title now.

Councilmember VanEtten: They changed the name.

**Supervisor Dellisanti**: The responsibility is covered is what you're looking for, but not the title.

#### Historian

Received a loan of photo negatives from Ron Lane, New Baltimore resident. Ron lives on Route 9W south of the Sterritt house, and found these negatives in the attic many years ago. I had some negatives printed at McGreery's Photo Lab in Albany. The photos – some of them anyway – date from circa 1910. There are many mysteries, but some of the photos are of an old stone house being dismantled on the site of the current Lane home. There are also photos of a large barn which Ron remembers was still there when he bought the place, and oxen being used on a hay wagon. One set of copies were made for Ron and one set for the town files. I appreciate Ron's sharing with me. Citizens of the town are invited to bring to my attention any photographs, newspapers, business or farm records or other items of historical importance that they find in their attic, find at a garage sale, find on ebay. Copies can be made and returned. If people do not want the items returned, they will be given a good home in the town archives or the Vedder Library at the Greene County Historical Society or both. Any items given to me as town historian do not become part of my personal collection. I also received a collection of old town assessor records which will also become part of the town archives. I will report on them in more detail in the future. I have been assisting Fran Degni in any way I can in her publication and photo exhibit on the hamlet school. The photo exhibit is currently at the Reformed Church Hall, and will travel to other sites in the county later this summer. Fran has done a tremendous service to our community in the preservation of oral history. Several items from the town archives are being displayed in the exhibit.

#### Agriculture

Agriculture has changed quite a bit in the last decade or so. I did a lot of research and talked to a lot of farmers, I talked to our County Agriculture Extension Mick Bessire who is an Extension Educator and Agriculture. I had a meeting for about two-and-a-half hours. I compiled some information, mostly state of the state as far as that goes. It's mostly facts and I then have some talking points. Agriculture is important to New York State's economy, and takes place in almost every region of the state. Nearly one-quarter of New York's total land area is utilized as farmland. In recent years the industry has generated billions in sales and employed tens of thousands of workers. While New York ranks 26<sup>th</sup> in the country in terms of overall agricultural sales, there are several item – such as dairy, fruits, berries, wine, and some vegetables and most recently hops in which New York ranks among the biggest producers in the nation. Farming in New York is primarily done by small, family businesses, but it is a multibillion dollar industry that supports thousands of jobs beyond those on farms. New York State's average farm is

smaller than 200 acres, or about half the national average. The work is difficult and profit margins are tight – less than 20 percent of farms generate more than \$100,000 in farm income. Many farms supplement their incomes by leasing their land for mining or wind turbines, and recently solar farms or relieve pressure by selling farmland for residential development. Farmers face many challenges. Access to credit, especially today, is difficult; with foreign completion being stiff, regulatory and economic factors that affect farm income. Low wholesale milk prices have cut deeply into profit margins for New York's dairy farmers, forcing many into foreclosure. That's one of my talking points. We are right down to one dairy farm in New Baltimore right now. While farming is an important industry in New York State, it is also a way of life. Growers often come from generations of farmers who have lived and worked in their local communities. In addition, farmers play an important role in protecting our environment, helping to develop new technologies that minimize water usage, prevent soil erosion, and maintain the productive quality of their land. The point is that with farming in our Town and many towns in New York, we are going to have to be willing to adopt to change. Change is the big thing that's moving along as far as agriculture. I mentioned there's only one operating dairy farm left in Town. When you talk to Mick, the County Cooperative Extension Agent, existing products and products that are new such as organic hay is a big money commodity now. Some farmers do it, some don't, but there's information available from the Cooperative Extension Agent on how to meet those guidelines and profit can be extensively higher with organic hay and it is a big market. I've been traveling around Town, there's a quite a few beef farmers that raise more beef and the big thing with those are grass fed livestock and also free range poultry. Believe it or not, I don't have any information on this yet, I was looked at him with a little bit of skepticism because I really don't know enough about it but I am going to look into it and get back to you later, is that raw milk is coming back. I drank raw milk. I went to New Baltimore Elementary School about that time, I drank raw milk strained through cheesecloth at my grandfather's farm. I don't know what the deal is, but I am going to find out more about it why it's a commodity that's gaining in popularity. Utilize the Extension resources available. He said he was from South Dakota originally, but he's got a lot of background in farming and we discussed the grass fed livestock. There's a lot of farmers that raise Angus and another variety he said was, and I didn't write it down, it's actually a better beef than the Angus but the primary thing is to educate raising the livestock and these grass fed livestock is called finishing. That's something I didn't know, there's a particular type of procedure that you need to do to get a better quality beef. Some farmers know how to do it and many farmers don't. It's a good thing to use the Extension Office's expertise and learn how to do that. Also at out AgFest coming up, we have the Agroforestry Resource Center, they'll help supply with wood lot management. There's timber people that are in the market, they're out looking to buy timber and they'll go to a farmer with property and they grade it. Well, there's people out there who will gladly give you a lesser amount. You really have to know how to grade the lumber. There's people that are being taken advantage of. When they come to the Ag Fest, they are going to have a booth set up and they are going to talk to people that have wood lots and show them how to manage them better to get the maximum amount of profit that they can from it. It's going to be a good thing. They are also going to have a nature walk.

**Councilmember VanEtten**: They are going to do a nature walk across the street from the AgFest and show different kinds of trees.

Councilmember Irving: One of the highest selling as far as profit margin in timber right now is ash and we have the ash borer. It's just a coincidence, but they're actually marketing ash down to about the size of eight inches. They make baseball bats out of them, they make all kinds of millwork. Ash is selling for an extremely high price right now. The last thing is that with the beef sales, grass fed beef, poultry, eggs, other livestock they're finding out in different parts of the state that a lot of the farmers are participating in direct sales, food co-ops, etc. They're doing quite well. We are seeing them start to sprout up, I think there's one out on Rt. 81 and I think there's one endeavoring in our Town, but I am going to look into that a bit more and find out the

Councilmember VanEtten: So how many more hours does that give her?

Councilmember Ruso: It ends up giving her a half-hour more per week. So as a rough idea about \$350 to the budget. Naturally that's not counting benefit time. Let's add on about \$350 to the budget. There are some other things that are a little complex though. If you work 6 hours or more you're required by law to have a lunch break. But she's only working 5 hours which means she doesn't get a lunch break or she does not need to have one. However, she has those two hours on any given one of those days or one hour on two different days, then she's going to hit the six hours so she needs to have a lunch break which is complicating factors because which day of the week are you working extra hours. I think it needs to be better defined is what I'm saying. If she wants to say 'I'll do Mondays and Tuesday's, I'll do the extra hours on Thursday or Wednesday' would be more helpful as opposed to saying 'I'm just going to spread it out and do it when necessary.'

**Supervisor Dellisanti**: You're talking about the Building Department.

Councilmember Ruso: Yes, those hours because when she adds those hours, it puts her into a different category. Once you exceed 6 hours; as long as she stays under 6 hours, that would be fine. But she can't do two on one day.

Supervisor Dellisanti: Bonnie already knows that when the payroll is done and someone's over 6 hours, she takes the half-hour for lunch.

Councilmember Ruso: So she just can't say I'll do the 2 hours on Monday or 2 hours on Thursday. It has to be no more than 1 hour on top of what she's already doing. Does that make sense?

**Supervisor Dellisanti**: If you're over 6 hours, you take a half-hour for lunch.

**Councilmember Ruso**: I'd still rather be defined better as opposed to loosey-goosey. That's my own opinion.

#### Insurance

Councilmember Ruso: I've been in contact with our Insurance Broker Erin Nevins. We're halfway through our current insurance period as of June 1. Our insurance increase for this year looks like, it's not finalized, but the Individual Plan for MVP has gone up by 6 percent which is a better increase than we've had. Now we don't have a final plan for Employer-Sponsored, don't have a final figure, but the 6 percent is generally roughly where that they're given for the Individuals where the Employers will come in. So the 6% increase is better than we've had in the last couple of years. Let's hope it holds out.

We will have to have an approved amongst us the approved plan in the event let's say next year someone retirees so they can plug into this other plan. It won't be the same.
