# Greene County EMS

The regular monthly meeting was held on December 20. There were 11 EMS calls in November for a total of 91 for the year and we had 75 calls for all of 2015 so we're a little bit up from last year's record. As of December 20, 2016, there is a projected year-end balance of \$270,000 which is good for the EMS Budget.

# Greene County Ambulance Task Force

The Task Force on a Countywide Ambulance has resumed its work. They have made no report as yet. We expect something to take place in the very near future. We'll hear that a little bit later from our Legislator.

# Fire Districts

Elections were held on December 13 for Fire Commissioners and Richard Cole was elected to the Medway-Grapeville Fire District and Cliff Meyer was reelected to the New Baltimore Fire District for a five-year term.

# County Legislator

December brings a close to my first year as your Greene County Legislator. While we have made progress on several fronts, there is still a lot of work to do. The jail project continues its forward progression, the Countywide Ambulance Task Force is ready to meet with Towns to move forward with a "plan B", broadband capability will move forward with a nearly \$9 million grant received this year, and Greene County has just received over \$2.7 million in county and regional economic development grant awards for 2017. All of this will require teamwork and cooperation. I am very committed to being a part of that team, and encourage anyone to contact me with their thoughts. They can contact me on the County website, I have business cards here at Town Hall, and my cell phone is out there. This first year has been educational for me with some good lessons and information. Having been through a complete budget process, there are some things that many of us would like to see done differently. In January, we will begin several workshop sessions with county department heads. These workshops will help us restructure our process through understanding, rather than dictating. We want to understand where that money is going, how it's being used, and is there a better way to do what we're doing. It will be a significant amount of work, and hopefully results in a more transparent and useful process that reduces the property tax burden by controlling costs. I look forward to exploring cost sharing initiatives in the coming year. County sales tax receipts are up 0.63% from 2015 which may not sound good, but many counties statewide are seeing negative growth numbers. We should be relatively close to hitting our budget number; we won't know for another six weeks or so. A note on delinquent taxes, the County will make school districts and villages whole in March at a cost of just over \$9 million. Those are county property tax dollars which will cover delinquent taxes. Notable resolutions this month include: 1) Authorizing the County Organizational Meeting for Jan. 3, 2017 at 6pm, 2) Increased income amounts for seniors and persons with disabilities tax exemptions by \$2,000 across the board, 3) Approved Ag District 124 inclusion recommendations, 4) Authorized the operation of Greene County Transit through Dec. 2018, 5) Authorized the purchase of a cab/chassis, as well as a dump body with snow/ice control

equipment, 6) Authorized the relevy of unpaid school and village taxes. I have been quite active this year in search of candidates for the Wayne C. Speenburgh Legislative Grant. I have one final 2016 grant to award tonight to Dan LaMora and the American Legion Post 1614 to assist them with their ongoing efforts in support of our Veterans all year long. Dan's not here tonight, but Ed Barber is here in his place. This will close out the 2016 grant period with 7 grants awarded by me, totaling \$11,000, including \$4,000 from other legislators in support of the Greene County Outlaws grant. In addition, I was able to support county wide applications brought forth by other legislators, such as Toys for Tots, Blue Star Mothers, Grandma's for our Troops, and others. Stay tuned in January for a strong start to 2017 on this front!

**Supervisor Dellisanti**: I just want to say one thing, Pat. You did a great job this year. We thank you for everything you did for the Town of New Baltimore.

**County Legislator Linger**: I appreciate that, I appreciate the help and guidance that I get when I ask questions and get answers too. I like that. I would like to invite Ed Barber up to accept this grant for the American Legion. It's a pleasure. This is exactly what we try and do with this money. We have a \$1,000 grant for you to assist with all your programs that you do for our vets to keep them active in the community all year long.

Ed Barber: Thank you very much, we appreciate it.

Supervisor Dellisanti: Thank you, Ed.

**Ed Barber**: Just a few words. We appreciate the work that the Town Board has done. Shelly VanEtten and Chuck Irving are on the local committee and locally we do the Veterans' picnic and we do the Veterans' dinner and so that is very helpful to all our active and retired veterans in the area. We do the Blue Star Mothers and Gold Star Mothers as well as support for the Stratton VA Hospital. Just a word about Stratton, I'm up there probably twice a month and the stories that you hear or read in the newspapers about the VA hospitals throughout the Country, not so with Stratton. It's an outstanding facility and they do a great job so we're pleased to be able to support them through the American Legion as well. So again thank you, Pat. I appreciate your work.

### Assessment

EXEMPTION RENEWALS All renewable exemption applications have been mailed out as of December 16. March 1<sup>ST</sup> is the deadline for all applications to be returned. The Greene county legislature has scheduled a public hearing to adjust the income limits for the senior citizen and persons with disabilities exemption sliding scale. The legislature is going to discuss a \$2,000 increase in those limits from a base of \$22,500 to \$24,500. Each level of the sliding scale would then get the same bump. The legislature has, in the past few years, taken the approach of a \$2,000 change every other year and made no changes last year. The town has historically made identical changes to keep all taxing jurisdictions at the same levels for ease of taxpayer understanding. The determination is to be made on the county level on December 21, 2017. Once we have received notice of the determination, we will inform the board. The Assessor's office wishes everyone a Merry Christmas and a Healthy & Happy New Year!
