## RESOLUTION TO ADOPT SUPERVISOR'S 2016 ANNUAL FINANCIAL REPORT UPDATE DOCUMENT SUBMITTED TO THE STATE COMPTROLLER AND ON FILE IN THE TOWN CLERK'S OFFICE FOR PUBLIC INSPECTION

WHEREAS the Supervisor shall submit to the Town Clerk, within ninety (90) days after the close of the fiscal year, a copy of the Annual Financial Report to the State Comptroller, and that the Town Clerk shall place a notice that the report is on file in the Office of the Town Clerk, to be so published within ten (10) days after receipt thereof, in the official newspaper of the Town of New Baltimore. Said report was submitted by the Town's Bookkeeper in a form approved by the State Comptroller on February 23, 2017.

Motion by Supervisor Dellisanti seconded by Deputy Supervisor Ruso

**Deputy Supervisor Ruso**: Thank you again, Nick. It is so difficult for towns with a tax cap and all those things, but I think you should be proud of the fact that you oversaw another year with a fiscal surplus. I just wanted to tell you we appreciate it.

**Supervisor Dellisanti**: I'd just like everyone to know this is the report -- it's about 80 pages long -- and our numbers were outstanding. This Board has done an outstanding job keeping track of all the expenses going down and making a concerted effort to look outside for ways to save money in the Town and it's obviously working. I think when Jeff reports on the fiscal stress of the Town probably at the end of 2017, you'll see that our numbers are going to be reduced a little bit better than they were before. There were some towns that have a 47 percent stress number.

**Deputy Supervisor Ruso**: Coeymans has a 76 percent, 70 something anyhow.

**Supervisor Dellisanti**: And I think ours is 6.3 or something like that.

**Deputy Supervisor Ruso**: Ours is 6.6 and because of this it will go down to 3.3. Zero is as good as you can get.

**Supervisor Dellisanti**: So the numbers are very good. I'm very happy about that and I just want to thank the Board for all their help.

**Town Clerk Finke**: I can also say I put it in the paper today and it will be in March 2, it's also on the sign board here, and it's on the website.

Ellie Alfeld: Excuse me, when you say you put it, are you saying you put the stress...

**Town Clerk Finke**: The Notice that it is available for public inspection.

Supervisor Dellisanti: The Annual Update report.

**Town Clerk Finke**: That I'm required to do in the resolution.

**Ellie Alfeld**: I was just going to suggest possibly making it known newspaper-wise, the stress point we're at.

**Deputy Supervisor Ruso**: The official release from the Comptroller's office won't be until later, probably August. They don't release it until about then; just jumping the gun a little.

#### County Legislator

February was a busy month. I'm sure everybody read the papers or saw it on the front pages on the Jail; don't buy into all of it. I don't talk to *The Daily Mail* too much anymore after being misquoted three times. In addition to our regular monthly committee meetings, we held a workshop meeting with the NYS Commission of Corrections. This is something we've been trying to do for quite awhile. This important workshop allowed us to get an overview of what they require of us for the new jail, what would and would not be approved by them, and the design for a new jail. It gives us a better idea of what we have to work with and what's more mandated that anything else. It allowed us to get an overview of what they required for a new jail and we were able to ask questions to the panel. We had approximately 50 people from the public attend, there was one from New Baltimore there, and also allowed them to ask questions to the Legislature when the C of C was finished. It was very informational for us, and enlightening for many in the audience. We truly have very little control over what can and cannot be done with many aspects of this project. We plan to hold more public meetings to get information out, but anyone is more than welcome to contact me with any questions at any time. If I don't have the answer, I can certainly get the answer either from the County Administrator, from the Sheriff, from the Commission of Corrections, from the architect, from our project manager. Like I said, don't buy into everything you read in the paper. They've made this pretty dramatic where it's really not, but that's what sells papers. Because of

this meeting and the answers we have, we are taking another look at bed count, as well as the potential for additional Alternatives to Incarceration programs that may be beneficial to us. It probably would not drop a prison count as it takes off, but to reduce a recidivism rate down in the future, that would certainly save us some money down the road. So we are taking a look at that right now. That has to include the District Attorney, it has to include the Probation Department, there's other than just the Legislature. We learned this month also that as part of the Governor's proposed budget, Greene County stands to lose funding for Social Services that will potentially reach nearly \$1 million. This is due to a proposed change in the grant funding formulas for child care and foster care. The mandates will remain, but the funding will potentially decrease dramatically. NYSAC has taken this issue to the forefront as an increase in unfunded mandates, to hopefully kill it before getting through the State Legislature. We have authorized the advertisement of bids for fuel oil, as well as extending the contract for the Household Hazardous Waste Collection Event. No date has been announced yet, but is typically done in early June. Notable resolutions passed in February: 1) Purchase of a 2014 Tandem axle truck with dump body and snow/ice control equipment for Highway, 2) Purchase of 2 New flail mower heads for existing tractors. I did get some complaints over the summer from the mowing on the sides of the road and it was very simply the mowers are worn out, 3) Purchase of 2 New loaders for Solid Waste, what we're attempting to do here is get on a replacement plan where these loaders are not worth next to nothing when we trade them. Right now there's very little that we can get for the loaders, they're so old and used. We are trying to get on a replacement plan and keep them in better shape and where they're worth something when we get rid of them, 4) Purchase of a vacuum sweeper truck through a Catskill Watershed Corporation grant and DEP. It's for the Mountaintop, we have one up there now. This is the second one. It can only be used on the Mountaintop. It doesn't cost us anything, we are going to run it. They pay for the training, they pay for the truck, 5) Appointed Kim Kaplan as Director of Public Health, 5) Appointed Ray Ward as Director of Real Property Tax Service. As a final note for February, I was happy to present a Wayne C. Speenburgh Community grant to our local Boy Scout Troop 45, in the amount of \$5,000. I was able to get all 14 legislators contributed to this grant which will allow 20 scouts to travel to Washington DC in April. While there, they will tour the Capital, the Washington Monument, and learn about the history of our Government. That is another one that I was able to get everybody on board

**Ann Marie Vadney**: The loaders how long do they typically keep the loaders?

for and they were all happy to do it. They will be heading to Washington DC.

County Legislator Linger: I would have to look for sure. We have a loader there that was an '89. We bought one last year. There's four transfer stations and part of the problem, I say it's a problem, it's not a problem because it's a source of revenue for the county, but the tonnage that comes into our transfer station has dramatically increased. That's by design. They tried to do that because our guys can actually bring in single stream recycling, bale the stuff up, and sell it on the market. So they're actually making money doing it; that wasn't true ten years ago. That was a dying entity, costing us quite a bit of money for solid waste. They've done a huge turnaround on it. The loaders that we have are different ages to answer your question.

**Ann Marie Vadney**: Is it a maintenance issue because loaders usually last for many, many years that's why I'm asking?

**County Legislator Linger**: No, they're used every single day and they're getting a lot of hard use. It's on pavement, they're not on grass and dirt so they chew up tires, it chews up transmissions. I can't say enough about the maintenance shop. They keep these things going really well. We actually purchased two sets of solid tires last year for a couple of the other loaders. This is just a replacement of loaders that are very old, over 25 years.

**Ann Marie Vadney**: On the child care and foster care cutbacks, if the State Legislature actually approves that, are there any estimations of the impact on the county taxes or what will occur, will there be cutbacks or will the taxes be increased to provide those services?

County Legislator Linger: I don't have an answer for that right now and only because a) it's not finalized as far as what that plan will wind up as whether it comes through at all or not. It's a proposal in his budget. At this point the second part of that is our budget is one of the things that we've taken on this year to have monthly budget meeting with departments to find out what part of their budget is a mandated fee and what part of their budget is cost that they can work with. Social Services is one of our highest portions of the County budget. Unfortunately a lot of it is mandated and not reimbursed. Some of it is reimbursed federally, some is reimbursed by the state, but a lot is not. So even though it's not reimbursed, it doesn't mean we're not mandated to provide service. We would still have to provide those child care/foster care services so depending on what's there that they can move on funding would depend on whether that was cuts or whether that was an increase. We're very well with the fact that we have to build a jail and that will increase taxes, we're trying not to increase them any more than what we have to.

**Ann Marie Vadney**: In preparation for this possibility are our County Legislators going to be asking the questions to Social Services as to how much would have to be cut back if taxes weren't increased versus if they want to retain the current level of service how much more taxes will be?

County Legislator Linger: The current level of service is the mandate so we don't have much of an option to drop that. As far as the budgeting goes, yes, that is questions that we are in contact with our Social Services Director, but she doesn't have those answers because they're not finalized as yet. They won't be until the budget is done and whether that passes through or not. Right now at this point, the only thing we can do is go to NYSAC and our State Legislators and demand that they not let this through. It's their mandate to us; they need to keep funding it. We don't have a vote in that other than in November when they're up for election just like mine or Town Board. You can go and you can demand and stomp your feet all you want and your best hope is that somebody listens to you, but we have at least 57 counties that are on board with this and as a group effort are fighting it with the State Legislature. That is something we will continue with our Social Services as well as other county departments. It's not just Social Services.

#### Historian

January: I handled a question from a paranormal investigator about an address on Saw Mill Road. I told him I didn't know of any ghosts or murders at that site. He also wanted to know if there were any Indian battles or Revolutionary War battles there, and I told him no. That saved him a lot of research time, he said. I reviewed several deeds provided to me by Clesson and Jean Bush regarding the Vanderpoel ice house in New Baltimore. I concluded, in agreement with Cless's conclusions, that the ice house buildings and equipment were treated as personal property and not as real property in the deeds. Usually, buildings are treated as real property. There will be a Slide show entitled "New Baltimore Hamlet: A History in Photographs" on Sunday February 26 at 3 P.M. at the Town Hall. (This has been changed from February 19.)

**Supervisor Dellisanti**: Ted's program was here on Sunday, the room was absolutely packed, standing room only and I think we'll be requesting space at the New Baltimore Fire Department at the next slide show. He did an outstanding job.

Councilmember VanEtten: It was very interesting.

**February**: I have spent about 4-5 hours interviewing Irving Smith of Sunset Hill Road about his life as a farmer, the dance hall which once operated at his farm and his other memories of local people and events. I have spent 20 hours or more transcribing the diaries of Augustus B. Conrad who lived on what is today Old Kings Road. A number of his diaries from between 1882 and 1914 are in a private collection. Augustus B. Conrad sold eggs, apples, buckwheat flour, honey, dressed turkeys, potatoes (lots of potatoes), butter, hay and cord wood to neighbors and to stores in Medway, Coxsackie, Athens, Coeymans Junction, Newton Hook and Albany. In his youth, he was a member of the Medway Cornet Band, and went to dances at the Odd Fellows Hall in Medway. He hewed timber, built stone walls, harvested ice and performed many other tasks common in his day. Upcoming programs of mine will be: (1) Thursday March 30 at 7 at Columbia Greene Community College. I will be participating in a panel discussion with two distinguished authors – Vernon Benjamin and Thomas Wermuth – on Hudson Valley History. Admission is free. (2) Saturday April 22 at 2 P.M. at Beattie/Powers House in Catskill, a slide show on "Lost Catskill." Admission is free.

### RESOLUTION AUTHORIZING SHARED SERVICES AGREEMENT WITH NEW YORK STATE DEPARTMENT OF TRANSPORTATION

**WHEREAS** emergency situations arise where the public would benefit from the sharing of services between the Highway Department and the New York State Department of Transportation in the absence of a Governor's Emergency Declaration and

**WHEREAS** this can be accomplished pursuant to Section 99-r of the General Municipal Law in an amount not to exceed \$10,000; and

#### Veterans and Memorials

#### Wastewater Treatment

Councilmember Irving: We had a report from our operator which pretty much parallels. We received a letter from DEC regarding their inspection on our plant; a very good letter addressed to our Supervisor. 'This morning (February 7, 2017) I conducted an announced annual inspection of the New Baltimore Sewer District wastewater treatment plant. I was accompanied by chief operator Louis Betke. The facility is very clean and well-organized, and the treatment processes appear to be running well. An overall satisfactory rating has been assigned for this inspection. It was noted that the Town has provided a computer and Internet connection at the plant to allow Mr. Betke to submit discharge monitoring reports in the NetDMR system. It was also noted that the Town still plans to proceed with significant plant upgrades, including an alarm system, a SCADA system, two new clarifiers and the conversion of the existing clarifier into a second digester. The continued commitment to the upkeep of the wastewater treatment facility is greatly appreciated.'

Net DMR Account Setup and we are now submitting our DMRS electronically (thanks to Scott's help in getting it set up), Plant Operating at 96% removal (85%) required, DEC Inspection All went well, Fuel oil will be needed for the standby generators, Preventive maintenance is complete and up to date, Follow up with Blue Diamond regarding sludge quote will resubmit, Greene County Septic will not submit quote at this time, but reserves the right to do so in the future, does not have the time, Flow Meter calibrated.

Supervisor Dellisanti: We got a good report for DEC which was excellent. Also from the Clean Water State Revolving Fund 'Dear Supervisor Dellisanti: The New York State Environmental Facilities Corporation (EFC) has reviewed your submission(s) for the referenced water pollution control project. Enclosed please find the EFC stamped cover page(s) for the following documents: Engineering Report entitled "Wastewater System Evaluation" dated December 2012, Revised May 2013, and Amended May 1, 2014 and prepared by Delaware Engineering. The reviewed submission is hereby approved and made eligible for Clean Water State Revolving Fund (CWSRF) financial assistance by the EFC.' This is a 0% financing loan through the 30 years that we're getting on the project. We now have it in writing and with the help of Delaware Engineering we're moving in the right direction. We also received from the Environmental Facilities Corporation 'has reviewed your submission for the referenced water pollution control project." Barb spent many days and nights putting this together, all of the background materials. They now have everything that they need and that has also been approved. Thank you, Barb, I saw all the emails.
