The Public Hearing was opened at 7 p.m. by Chair Rob Van Etten. Other Board Members in attendance were Ann Marie Vadney, Bob Court, Pat Bruno, Bill Boehlke, Lee Salisbury and Frank Orlando. Present on behalf of the applicant was authorized representative Kevin Conklin from Conklin Architecture.

All requiring notification had been notified.

Copies of the Site Plan were laid out. Mr. Conklin advised since the last meeting the items that were discussed and have now been added to the plan are:

... Two pole mounted lights were added, one on the southern gravel lot behind the building and the other on the western asphalt parking lot that was added some years ago.  
...The proposed curb cut to the adjoining properties was put on.  
...The third item was widening this existing gravel road so when it is finally used, people could pass without driving off into the field.  
...The Zoning information has been updated.

It was noted that with the widening of the road to the 24 feet would put the lot coverage at 33 ½%. It was believed the zoning allowed for 30%. Mr. Van Etten felt that small difference would be splitting hairs. A 22-foot calculation was not done to determine coverage but it was not felt the desired radius really could be obtained at the 22.

No one from the public wished to address the Board on this application.
