GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

This policy will be amended by Majority vote of the Town Board.

I would like to begin 2020 by welcoming new Town Board member Bill Boehlke, and congratulating Chuck Irving, Supervisor Jeff Ruso, and Highway Superintendent Alan VanWormer on their re-elections as well. We held our Organizational Meeting on January 6, where I appointed a new Chair of Public Safety. Tom Hobart from Coxsackie will be the Chair, replacing Bill Lawrence of Cairo. We also approved the Times Union as the newspaper for printing of all official notices. We have scheduled a Public Hearing on the review of Agricultural District # 124 for February 19 at 6:25pm in the Legislative Chambers. As you are aware, GC Public Health schedules rabies clinics each year around the County. This year, there will be a clinic held at the Medway-Grapeville Fire House on March 25 from 6-8pm. This is a free clinic, but donations are encouraged to help offset the cost. Other clinics are available with the schedule posted on our website under the Public Health tab. We have accepted several grants for 2020 this month. We received \$114,000 from Homeland Security to be used for Emergency Services and the Sheriff's department. We have received \$150,000 to form a joint Greene-Ulster Technical Rescue Team. Two teams currently exist independently, using equipment owned by the Greene County side. This will put training and equipment in both counties as they work together. We have tried for several years to figure out a solution NYS would approve of to the dangerous area of Rt. 145 at the Cairo-Durham High School entrance. We received \$50,000 from NYSDOT for new speed detection and reduction equipment to be placed in that area and this should help slow the traffic in a limited sight area and help to hopefully avoid the serious accidents that have occurred there over the years. An issue with the Property Tax bills was brought to my attention by the Town Supervisor. I have been working on this with the Attorney, Real Property Services Director, County Treasurer, and County Administrator to try to figure it out. When the attorney returns from vacation, we'll schedule a meeting with the Supervisor. The NYS plastic bag ban approved in last year's budget goes into effect on March 1st of this year. While counties were given the authority to assess a fee of up to 5 cents per bag, GC has opted NOT to assess this fee. The law states we would only receive 40 percent of the fee, and the State would receive 60 percent. We believe imposing this would hurt those who can least afford it the most, to the States benefit. Albany County and Ulster County have both imposed the fee. On March 31st of this year, the County will pay out \$9,831,537 in unpaid taxes to make villages and school districts whole. This is a slight decrease from last year, and the funds are set aside so no bonding will be needed. The single biggest revenue source for Greene County is sales tax. It's also a source we have very little control over and budget conservatively for. At the end of 2019, our sales tax collections exceeded budgeted revenues by over \$3.4 million dollars. Tourism is up 8.5% over last year, and we have over 16,000 private sector jobs in Greene County, the highest number of jobs on record. We have scheduled workshops for the next few months to assess the year-end closeout, Highway, Buildings & Grounds, and then the 2021 budget. This month we actually just added another public hearing on the demolition of the old jail for February. This month, we approved the contract with our nurses' union as well. Last week, I was invited to attend a

Legislative Forum hosted by the GC Chamber of Commerce. I was joined by Congressman Delgado and Assemblyman Tague. As I listened to the other panel members giving their respective 2020 Federal and State priorities, I was glad to see GC is ahead of the game with boots on the ground already working on many of the same issues. One of the goals I've had since my election to this board is to be more proactive and not always finding solutions out of necessity. We are succeeding at this. Last week, the IDA announced an agreement with CMH on purchasing property off 23B in Catskill to build a medical complex. This will be a joint venture with Albany Medical Center and Northeastern Oncology and Hematology. While there are still many details to be worked out, this complex will sit on approximately 4 acres, and include a cancer treatment facility, among other medical offices. These are clean, high-paying jobs coming to Greene County. We have five hotel proposals in different stages right now as well. Mr. Cat in Catskill is under construction, Aaron Flach has announced a project on South River St in Coxsackie that has received some grant funding already, another smaller restaurant/hotel developer is in negotiations on Reed St. in Coxsackie, the former Catskill Country Club is in the approval phase of a larger hotel project, and the IDA is very close to signing with a hotel developer on the former Quality Inn property next to the Catskill Thruway interchange. The County took ownership of that parcel last year and signed an agreement with the IDA to develop it. There are still some acquisitions to finalize with the thruway, but the result should be four individual parcels. A new 75-room hotel will sit on one with potentially a restaurant and retail on the other three. The deal for the hotel will be structured so GC is repaid for any taxes owed and costs incurred to date, and any profit then will be split with the IDA. County taxpayers will be made whole first. We also have a \$50,000 grant from Assemblyman Tague to help offset the cost of building a new roadway into the new parcels. This project is quite involved, as it will encompass the new cashless tolling, the park and ride entrance, and our travel and tourism center. I do expect this will be an exciting year for Greene County and appreciate the opportunity to serve as Legislator for the Town, as well as the Chairman for the Board. I also expect to work closely with the Town Board and Highway Superintendent as I have done since 2016.

Eileen Vosburgh: I read an article in the *Daily Mail* actually from Hudson Valley 360 and it talked about the cut, that they had cut ties with the *Daily Mail* and made the *Times Union* the County's official paper. It went on to say you know the *Daily Mail* had important legal notices that people in our County would want to see and it also gave them significant revenue, but the issue was that it doesn't seem that the *Times Union* comes down to our area. They said that the *Daily Mail* printed more than 1,000 local stories, staff-driven press releases, assorted briefs and announcements in 2019 where the *Times Union* printed only 34 stores and I'd like to know what that decision was based on?

County Legislator Linger: That was a decision by the Board. There's not really an official paper for the County, there's a paper to publish official notices. So that's what was changed. We have five newspapers actually that circulate actually in Greene County. The *Daily Mail* has been the paper that we published our official notices in for a long time. There was a push to move it to somebody else to spread the wealth around here. We did some circulation numbers for the *Times Union*, the *Daily Mail*, and the *Daily Freeman*. The *Times Union* actually has almost 9,000 papers here in Greene County on the weekend, far exceeding what the *Daily Mail* has. But, basically that was a vote of the Board. So I think ten Legislators voted in favor of changing that, three voted against, and one was absent.

Eileen Vosburgh: But truly the *Times Union* really doesn't come down here.

County Legislator Linger: There were two articles in the *Times Union* yesterday from Greene County.

Eileen Vosburgh: Okay, but they did their study. It was 34. The *Daily Mail* gives much more coverage.

County Legislator Linger: And I'm sure they still will. It won't preclude the *Daily Mail* from doing their job or publishing a paper here or doing stories here. It doesn't preclude that. All this does is move our official notices to a larger market.

Councilmember VanEtten: I think probably you would have to go to a County meeting to debate this.

Supervisor Ruso: From what I remember hearing, there were a couple things about -- we've endured it a little here because we still have the *Daily Mail* -- but contractors, the big contractors, when we put our notices in for paving, haven't been finding the *Daily Mail* so we don't get as many bidders. Now that was just an observation that one of the contractors said to me 'I didn't even know about it. I thought I'd see it in the *Times Union*.' That was last year. I don't know it that relates to...

County Legislator Linger: Right, most of your bidders that look in the paper for bid proposals, will check the *Times Union*. Some of those also check the *Daily Mail*, but not all of those who check the *Daily Mail* are checking the *Times Union*.

Supervisor Ruso: That's only one contractor said it to me, I don't know if that's the issue elsewhere.

County Legislator Linger: I had the same.

Eileen Vosburgh: I can understand that point, but truly the *Daily Mail* is -- people count on that for the information and what about the Legislature's Buy in Greene County? Now we're sending that money outside for that.

Councilmember VanEtten: Actually the circulation of the *Daily Mail* in New Baltimore is very low.

Councilmember Downes: Very low.

County Legislator Linger: It's very small and...

Eileen Vosburgh: You'd be surprised how many people contacted me about this situation.

Councilmember VanEtten: Oh, really, nobody contacted us.

Town Clerk Finke: Doesn't deal with us.

Councilmember VanEtten: Yeah, it doesn't deal with us.

County Legislator Linger: The other issue that we had and we were getting complaints as Legislators were people who were subscribing to the *Daily Mail* not getting delivery. Some of those folks were refunded their money. The checks bounced. That's a problem.

Councilmember VanEtten: Have you, as Legislators, had a lot of people contact you about this change?

County Legislator Linger: I have not personally. This was discussions that were had. Actually they started last year and the *Daily Mail* has not been very responsive to either myself or the County Administrator when we've called. So all of it goes into the decision-making and then there's a vote by 14 people and whatever the majority votes to do on that is where we go.

Supervisor Ruso: Okay, if I can move onto a different topic. I'm always curious about health care issues and I'm trying to envision the location of the oncology treatment center?

County Legislator Linger: Do you know where Anthony's Restaurant is?

Supervisor Ruso: Yes.

County Legislator Linger: Directly across the street.

Supervisor Ruso: Okay, now I know.

County Legislator Linger: So it's on the West side of 23B.

Supervisor Ruso: Okay, that helps. Thank you.

Ellie Alfeld: Two questions for you. Has the outfit that has proposed this medical center, you said four acres, do they have a lease on any adjoining land because if it's very successful as New York Oncology Hematology is in all the surrounding upstate areas, I would think they might be in need of more land? So do they have any ideas or plans for any extensions if it is successful?

County Legislator Linger: I don't know the answer to that for sure. It's an IDA project. It is IDA-controlled property, but when I talked to Rene two weeks or so ago about it with the Executive Director for the IDA, they were signing on for four acres. Beyond that I don't know and there's not other than the cancer treatment center, there's not a lot of details yet that have been worked out only that's is gonna be a partnership with CMH, Albany Med, and AOH.

Ellie Alfeld: I did see that in the paper. Second thing mention the papers as Eilleen was. I contacted the *Times Union* over two years ago for the lack of coverage that we get in Greene County.

County Legislator Linger: I have as well.

Ellie Alfeld: And I hope their response to you was not what it was to me and they said 'there's no interest in Greene County and that's why we don't have cover. You have your own paper to cover your area.' Well, that would be good except for the fact that as a resident in New Baltimore I feel like we're almost in no man's land. The *Times Union* doesn't want us. Greene County, Catskill, and further south sometimes I wonder if they even know we're up here or that they consider us southern Albany still. But we have to have some more input as to what goes on in this Town as per even this Public Hearing tonight which impacts what we have and that is a number of seniors. We gotta get the word out and we've gotta get a newspaper that's gonna put our projects on...

Supervisor Ruso: This was published in the *Daily Mail*. This meeting.

Councilmember VanEtten: And we have no control over who comes and who doesn't.

Ellie Alfeld: And I realize that, however, we also know that and I agree with you, I've talked to people that have had complaints against the paper and got their monies back because of lack of delivery. So I just think that somewhere along the line we've got to get better coverage from somebody whether it's the *Times Union*. I don't care if it's Westerlo newspapers. Sometimes they produce more information.

Councilmember Boehlke: What's boiling down to us is supply and demand-type of thing, Ellie, truthfully because so many people now are just getting their news off the internet. Papers are falling out of favor I mean and it's not just in this area. I mean you take the *New York Times* and the *Washington Post*. I mean that's where it's going. They're bleeding.

Councilmember Downes: But by putting what Pat and the County is doing, putting those notices into the *Times Union* is only going to be a benefit for the taxpayers of Greene County because you're going to get more people interested, they can do it for cheaper money. They're not even talking about something happened at the Legislature and somebody's reporting on it. So it makes a lot of sense for us to go to a larger newspaper so we benefit.

Ellie Alfeld: Oh, I realize.

County Legislator Linger: And we don't know how this will play out over the year. If it doesn't work out, then there's nothing saying that at next year's Organizational Meeting we go back to the *Daily Mail*. This was a decision that was made by the Board for this year to see how it works for us.

Eilleen Vosburgh: So how will you gauge that depending upon how much per article?

Councilmember Downes: It's not articles. It's not articles.

County Legislator Linger: I don't if it will be articles, it will be gauged more on what bids we're putting out and what kind of response we get back. Do we have more people showing up at public meetings because more people saw the announcement. Those sort of things and public hearings.

Councilmember VanEtten: So they're trying something different.

County Legislator Linger: It's something that we've done for years with one paper and was just time to move to something else and try something that was different.

Eilleen Vosburgh: But how can you compare 1,000 articles versus 34? Do you expect to have I mean articles are important.

County Legislator Linger: True enough, but I can...

Councilmember Downes: We're not taking articles out of the *Daily Mail*. They can come, they can report. They're talking about bids and that type of thing. They're talking about business to do in Greene County. They're not talking about stopping articles. If the *Daily Mail* wants to come in and do an article, they can do it. That has nothing to do with they tell the *Daily Mail* they're going to put our bids and stuff in the *Daily Mail*. That has nothing to do with articles. Articles are about what is going on. Bids are money that type of thing if we're selling properties. So we want what's best for the...

County Legislator Linger: I've also corrected many articles right here in my report that have gone out that were just not true at all, were just negative reporting and our tax money is going to fund that newspaper and they're not being responsible enough to report factual information. So I've corrected many articles right here in my report in the three years that I've been there. So if we don't see a difference over the next year, that vote comes up again next year.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of New Baltimore does hereby adopt Local Law 1 of 2020 Establishing a New Schedule of Real Property Tax Exemptions for Persons Sixty-Five (65) Years of Age or Over and Persons with Disabilities and Limited Incomes.

LOCAL LAW #1 OF 2020

A LOCAL LAW TO ESTABLISH A NEW SCHEDULE OF REAL PROPERTY TAX
EXEMPTIONS FOR PERSONS SIXTY-FIVE (65) YEARS OF AGE OR OVER AND
PESONS WITH DISABILITIES AND LIMITED INCOMES

BE IT ENACTED by the Town Board of the Town of New Baltimore, as follows:

SECTION 1. This Local Law is adopted pursuant to the authority of Real Property Tax §459© and §467. All definitions, terms and conditions of such statute shall apply to this Local Law and are incorporated herein.

SECTION 2. Local Law #1 of 2019 is HEREBY REPEALED.

SECTION 3. The Town Board of the Town of New Baltimore does hereby establish the following sliding scale of property tax exemptions for real property owned by persons sixty-five (65) years of age or over and for real property owned by a person with a disability whose income is limited by such disability, and used as the legal residence of such person, based on the income limits set forth below:

\$35,600.00-\$36,499.99	10%
\$36,500.00-\$37,399.99	5%

SECTION 4. Any person who qualifies for a property tax exemption as a person with a disability shall not be eligible for a property tax exemption as a person who is sixty-five (65) years of age or over.
