**** Agenda Subject to Change**** GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

- 1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
- 2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
- 3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
- 4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
- 5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
- 6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
- 7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

RESOLUTION SETTING PUBLIC HEARING FOR A PROPOSED LOCAL LAW TO ESTABLISH A NEW SCHEDULE OF REAL PROPERTY TAX EXEMPTIONS FOR PERSONS SIXTY-FIVE (65) YEARS OF AGE OR OVER AND PERSONS WITH DISABILITIES AND LIMITED INCOMES

BE IT RESOLVED, that the Town Board of the Town of New Baltimore will hold a Public Hearing on January 9, 2023 at 6:45 PM at the Town Hall, 3809 County Route 51, Hannacroix, New York to hear those members of the public who wish to be heard regarding proposed Local Law 1 of 2023, a Local Law to establish a new schedule of real property tax exemptions for persons sixty-five (65) years of age or over and persons with disabilities and limited incomes.

PROPOSED LOCAL LAW #1 OF 2023

A LOCAL LAW TO ESTABLISH A NEW SCHEDULE OF REAL PROPERTY TAX EXEMPTIONS FOR PERSONS SIXTY-FIVE (65) YEARS OF AGE OR OVER AND PESONS WITH DISABILITIES AND LIMITED INCOMES

BE IT ENACTED by the Town Board of the Town of New Baltimore, as follows:

SECTION 1. This Local Law is adopted pursuant to the authority of Real Property Tax §459© and §467. All definitions, terms and conditions of such statute shall apply to this Local Law and are incorporated herein.

SECTION 2. Local Law #1 of 2020 is HEREBY REPEALED.

SECTION 3. The Town Board of the Town of New Baltimore does hereby establish the following sliding scale of property tax exemptions for real property owned by persons sixty-five (65) years of age or over and for real property owned by a person with a disability whose income is limited by such disability, and used as the legal residence of such person, based on the income limits set forth below:

SECTION 4. Any person who qualifies for a property tax exemption as a person with a disability shall not be eligible for a property tax exemption as a person who is sixty-five (65) years of age or over.

SECTION 5. The maximum income limit set forth in Section 3 above shall be offset by medical and prescription drug expenses actually paid which are not reimbursed or paid for by insurance.

SECTION 6. This Local Law shall take effect immediately upon its filing in the Office of the Secretary of State.

Resolution No. 409-22

Increasing Amount Of Income For Senior Citizen Tax Exemption

WHEREAS, pursuant to Section 467 of the Real Property Tax Law, persons sixty-five (65) years of age or over who are owners of real property shall be exempt from County taxes to the extent of fifty per centum (50%) of the assessed valuation if said owners fulfill certain qualifications, including a limited income which does not exceed an amount fixed by this Legislature;

BE IT RESOLVED, that the income of the owner, or the combined income of owners of real property who are sixty-five (65) years of age or over must not exceed \$34,000.00; and be it further

RESOLVED, that this income amount shall be effective for the assessment rolls to be completed and filed beginning in 2023; and be it further

RESOLVED, that the "sliding scale" provisions of Real Property Tax Law Section 467 paragraph 1(b)(1) adopted by this Legislature by Resolution No. 583-01 on December 19, 2001, and Real Property Tax Law Section 467 paragraph 1(b)(2) and 1(b)(3) adopted by this Legislature by Resolution No. 477-04 on December 15, 2004, shall remain in effect.

Senior Citizens living in Town of New Baltimore who are 65 years old or over will be eligible for these reductions in school taxes if their income level is \$42,399.99 or lower.

District residents with a disability whose income is limited by such a disability will be eligible for these reductions in school taxes, if their income level is \$42,399.99 or lower.

Anyone who is eligible for this exemption must contact their local assessor's office (in the township they live in) prior to the deadline for filing of March 1st.

SEQRA Declaration And Approving Recommendations For Including Land Into Agricultural District No. 124

WHEREAS, in accordance with Article 25-A, § 303-b of the Agriculture and Markets Law of New York State the Greene County Legislature has designated an annual thirty day period as October 1st through October 30th within which a land owner may submit a request for inclusion of land which is predominately viable agricultural land within an Agricultural District prior to the county established review period; and

WHEREAS, upon the termination of such thirty day period the County Legislative Body shall follow the procedure proscribed by Article 25-A, § 303-b of the Agriculture and Markets Law of New York State; and

WHEREAS, the Greene County Agricultural and Farmland Protection Board has compiled a report of its recommendations as to whether the requested lands be included in the agricultural district as consisting of predominantly viable agricultural land as well as parcel mergers within the District and serving the public interest by assisting in maintaining a viable agricultural industry within the district; and

WHEREAS, a Public Hearing was held by the Greene County Legislature on December 14, 2022; and

WHEREAS, the Greene County Legislature has considered factors contained in Article 25-A, § 303-b of the Agriculture and Markets Law and of 6 NYCRR Part 617 (State Environmental Quality Review), with respect to said district and proposed additions.

NOW, THEREFORE, BE IT RESOLVED, that after due deliberation and pursuant to the Agriculture and Markets Law, the Greene County Legislature hereby determines that the amendment to Agricultural District No. 124 recommended by the Greene County Agricultural and Farmland Protection Board will not have a significant adverse environmental impact and therefore an Environmental Impact Statement is not required; and be it further

RESOLVED, that the Greene County Legislature hereby approves the modifications to Agricultural District No. 124 as recommended by the Greene County Agricultural and Farmland Protection Board.

Tax Exemptions - 2023 Maximum Income Limits

Each year the Greene County Legislature reviews the maximum income limits for the "Aged Senior Citizen's Tax Exemption" as well as the "Persons with Disabilities and Limited Income Tax Exemptions" for county tax purposes. These exemptions use the property owner(s) gross annual income from all sources to determine eligibility.

This year, the NYS legislature addressed that they had not raised the maximum income limits from \$29,000 pursuant to Real Property Tax Law §467 & §459-c since 2009. Senate Bill S3085-A and Assembly Bill A3596-A were signed into law on August 8, 2022, allowing by local option, to increase the maximum income limit up to \$50,000.

Greene County has not raised the income limits from the maximum of \$29,000 since 2019 for use on the 2020 Assessment Roll. Our current limits are:

<u>Public Hearing</u> was held on the Marjorie McCoy Minor Subdivision Application submitted at October Meeting to correct the status of parcel owned on Medway-Earlton Road.

In the Regular Monthly Meeting that followed:

...McCoy Minor Subdivision was approved. Required maps and mylar approved for submission by applicant to the County Clerk's Office

...Held discussion with Teichos Energy representative and attorney regarding the renewal of the Site Plan for the Hannacroix Solar Project. At end of discussion, resolution was passed extending the Site Plan for another year expiring on December 8, 2023.
