GUIDELINES FOR PUBLIC CONDUCT DURING TOWN BOARD MEETINGS

1. The Supervisor shall preside at the meetings of the Town Board. In the absence of the Supervisor, the Deputy Supervisor shall be the acting Supervisor. In the event both the Supervisor and the Deputy Supervisor are absent, the other members shall designate one of their members to act as temporary chairman. A majority of the Board shall constitute a quorum for the transaction of business, but a lesser number may adjourn.
2. Town residents who wish to speak shall fill out a card at the entrances of the meeting room listing their name, contact information, and the subject matter in which they would like to speak. These cards will be collected prior to the beginning of the Town Board meeting and given to the Town Supervisor or Deputy Supervisor in the absence of the Supervisor.
3. Speakers must be recognized by the presiding officer and then proceed to the lectern and state their name and address. They must limit their remarks on official town business to up to three minutes on a given topic and may not yield any remaining time to another speaker. They must address their remarks to the Board as a body and not to any member thereof and not to other members of the audience in the form of a debate.
4. Speakers should present their remarks in a courteous manner and may not make disparaging remarks or personal comments about public officials, town residents, or others. All speakers will observe the commonly accepted rules of courtesy, decorum, dignity, and good taste with no cursing, swearing, clapping, booing, finger pointing, bullying, whispering, or talking that disrupts the proceedings of the business of the Town Board.
5. Any speaker who disregards the directives of the presiding officer in enforcing the rules, disturbs the peace at a meeting, makes impertinent or slanderous remarks, or generally conducts themselves in an inappropriate manner shall be barred from further participation and will forfeit any balance of time remaining for their comments.
6. After a final warning, if a speaker willfully refuses to step down, the Town Supervisor shall contact the appropriate authorities to remove the speaker from the meeting room and to restore order.
7. The Town Supervisor, or in their absence the Deputy Supervisor, shall ensure compliance with these rules.

Councilmember Boehlke: Well, you know what Ellie, we can raise the possibility of them when we meet with them about coming to the Town and doing a public presentation.

Supervisor Ruso: I've already discussed that with them.

Ellie Alfeld: You know it's like everything. The public doesn't know what's going on half the time until after the fact and if we don't know how we're being impacted, we're the one's paying the taxes on this property.

Supervisor Ruso: It's the Road Use Agreement is what we're talking about. That's the topic.

Ellie Alfeld: Well, I have the agreement you're coming through my property to get where you're going. How's that?

Supervisor Ruso: I think it's the other way around. They're coming down from the north across New Baltimore Road.

Supervisor Ruso: They don't discuss the properties with me.

Ellie Alfeld: Right, right, and they don't discuss it with general public either. Thank you very much.

Supervisor Ruso: They can't go on your property without your permission.

Ellie Alfeld: Oh, yes they can.

Supervisor Ruso: No, not approved by us.

Ellie Alfeld: We'll see.

Harold Vadney: Didn't you ever hear of Eminent Domain?

Supervisor Ruso: That's on them, that's not us. That's a state thing.

Harold Vadney: They can go on your property without your permission.

Councilmember Boehlke: Well that's done through the Courts before it's enforced.

Unable to Understand

Councilmember Boehlke: They don't just walk on your property (unable to understand).

Supervisor Ruso: Until there's such a thing ever happens, they can't go on your property. They need to knock on your door and ask you. That's what they need to do.

Ellie Alfeld: I'll submit to you a copy of the email I was sent by their chief of surveyors. How's that telling me exactly where this (unable to understand)?

Supervisor Ruso: That would be good. I'd like to see it. Well, nevertheless, year one they are going to give us, the Town, and we're expecting 2025 \$267,734 and every year it goes up by a few thousand dollars. You know it will be \$270,000 the next year, then \$272,000 and so forth.

Audit and Budget

Supervisor Ruso: So now the first thing we want to do is I need to present some issues on the budget. Just some general points before we proceed. The process and the approach is significantly to address the Revenue and Expense side based upon our experience of this year and next year and the year beforehand excuse me. And so we have a rough idea as to where our costs will be if all things stay the same. Department Heads have been contacted and the question is what is different this year in terms of expenses and/or revenue if that's the case then what we've experienced in years gone by. So anyway the Tentative Budget is based upon previous years and occurrences. So if you look at the very first page for instance, we're not going line item by line item, but there's a lot of pages here, our taxable amount on Page 1 of 5 of the New Baltimore General Fund is \$505,000 taxable amount and it's various ancillary revenue accounts are described below. There are a few worrisome points that we have. For instance in 2022 we had \$107,000 in Court Fines and Fees and in terms of revenue, our budget for '22 is \$87,000. However, in 2023 our actual is way down. Now mind you that's through June 30th, we only have \$25,000 in Court Fines and Forfeited Bail. Nevertheless, we've brought our estimated budget down from the 2023 figure of \$95,000, we brought it down – we don't know how far this trend will go downwards, but it's a concerning trend. There are some things where we have improved in terms of our income. If you look at the line item for Interest and Earnings, in years gone by if you look across, you'll see we had \$560 in '21. We have \$1,464 in '22 and we have \$13,193 in '23 and that's only through half of the year. I don't know if anyone recalls, but back then I sat and went to each of the banks around here and talked about interest we get on our accounts and we went from .05 of a percentage point to 3 and/or 4 percentage points. So that has much to do with that greater increase. So, through June 30, we have \$13,000, one can anticipate we could have up to \$26,000 for a full year. I don't want to go too high, that's why we budgeted \$22,000. So on the Summary page our overall taxes to be raised is \$505,000 for the General and \$547,000 for the Highway. And again there's offsets to all of that. The way we budget we usually budget first the ancillary income and then we budget our expected expenses and what happens is the expected expenses subtracting the ancillary income is the basis of our taxes. So that's where we are and, of course, every line item is a guess based upon past practices -- what is the cost of fuel next year? I don't know. We have rough ideas but we really don't know. What's the cost of lighting? I know last year the lighting went up significantly -- 2022 particularly and early '23. So these are estimates based upon past practices with knowledge of any things that may be new or different this year that need to be inserted into the budget. So I guess you guys get to study it for awhile. Our Preliminary Budget, we're gonna address that shortly and then our Final budget and all that will be scheduled. So any thoughts guys? I know Kelly was one of our budget officers that worked on this a great deal and I know that we have tried to keep you guys in the loop as much as possible. So let me go then to Resolution 110, we're gonna set a Public Hearing for the 2024 Preliminary Budget, the second step of three.

Hughes Expert tree service will cover the Western half with Route 51 being the dividing point. We are still able to get a smaller bucket truck from the Town of Athens when available, but large trees will have to be contracted out, and this will be an added expense to our Town. Update on Chips All paperwork for Staco Road has been submitted, reviewed, and is in order in the amount of \$121,357.70, All paperwork for High Rock Road and Roberts Hill Road is completed and awaiting cancelled check in the amount of \$190,043.29, Total from Chips, PaveNY, EWR, and POP \$311,400.99, Balance to be paid from 5110.4 \$24,577.95 \$24,577.95 Total \$335,958.94

Steve Pilatich: I've lived up on Jennings Road for over 40 years and one area of the road there is about a lane-and-a-half wide and the Town plow knocked over one of the trees and it still lays there. They took the limbs off where it lays along the road. People stop there to pull off, let the other lane to by and then come back out. So it's an obstruction. A while ago the neighbor across the street blacktopped his driveway and, of course, everything pitches to the house and they put some berms and stuff by the house to divert the water. Then the Town came, blacktopped the road, and as they were blacktopping the road, I happened to be out there and that narrow spot where the erosion was they were starting to fill the ditch in and I said 'whoa, what are you doing?' and we were told to fill the ditch in and I says 'well, you're not filling it in.' So Alan came. I spoke with Alan. He said he didn't tell 'em so they put the road where it belonged. They did still come over. Alright now Alan now put a berm across Hamilton's driveway diverting water all to me. I don't need that erosion. I spoke with Alan about it and he says 'let me know if it don't go through the stone wall.' Well, it's not gonna go through because the stone wall's plugged and on the other side is a flower garden and the way that it's laid out there the water is going there, coming down along inside along the road, hits by my mailbox across from the road. It does it at low flow and it does it now on high flow. Also ahead of that berm is a blob of, I don't know what it is. Alan said 'I didn't put that there.' But what that's done is pushing the water onto the road as it comes down the grade, hits that, takes it out. I get it, okay? Highway Law as I know it says you can't do this. You can't dump water on somebody else's property and I think in the Highway Law the Town Board has some authority there okay? Spoke with Alan, I get no results and putting that blob is illegal to divert it out. Would like the Board to resolve the issue. Now he built the stone wall there and we had a court case and a lot of lies were done and he won his case. There was never a wall there. However now since the road is narrow, two mirrors on my truck have been broke by other trucks going by and we're hitting

mirrors, \$611 a mirror. So that takes care of that. Again, I'd like to resolve it. Now you had a resolution on a 2002 plow truck, \$9,000 for a head gasket. I think that's a 2012 and that motor was overheated so I don't think \$9,000 is gonna fix it unless they pulled the head and checked it, but when you overheat a motor, usually the head get warped so thank you.

Councilmember Downes: This plow truck that you were talking about, you think that's a 2012 not a '2?

Steve Pilatich: Yeah, I believe it's a 2012 not a 2002. I could be wrong, that's what I heard a 2012.

Supervisor Ruso: The information we have... We can confirm that.

Councilmember Downes: It said 2002 on here so I just wanted to make sure we were talking at the same.

Steve Pilatich: I think that's the one that's a 2012.

Councilmember Downes: You believe it's a 2012.

Steve Pilatich: Because it said they were gonna put a head gasket on it. It was overheated so, but I heard it was a 2012. I'm not sure.

Supervisor Ruso: As a thought maybe yourself and myself could try to resolve the issue I mean with Alan. The three of us meet. Can we set up a meeting where Alan, you and I?

Steve Pilatich: Okay.

Supervisor Ruso: Can we do that?

Steve Pilatich: Sure.

Supervisor Ruso: I'll give you a call and after Alan's back obviously okay.

Steve Pilatich: Okay, thank you.

Supervisor Ruso: Alright, thank you.

Harold Vadney: To be very, very brief for a change I would note that this situation with the berm's diversion of natural flow off of properties, screwy louie construction and paving activities is turned into a patterned and perennial problem in this Town. Almost to the day I submitted to this Town Board a memorandum of law in which I summarized Town Law most principally Highway Law 140, 284, and Town Law 64 and 32. Almost to the day on September 26, 2017 I submitted to this Town Board a memorandum of law which summarized Town Law, Highway Law, and various advisory opinions of the Office of the Comptroller on these very, very same issues and this is over six years ago. The memorandum of law was based on events that happened well before and during this time and you are very familiar with this and so is Dellisanti, at the time it was Denis Jordan Superintendent, then it was Scott VanWormer, and then finally Alan was elected to be Highway Superintendent. So we have an entire group of people who are intimately familiar with this issue and other issues of almost exactly the same type. In the meantime we've been paving, berming, and putting up retaining walls with no rationale whatsoever. This is being done by the Highway Department under the direction of the Highway Superintendent and under the eyes and auditing authority of the Town Board. Now Town Law provides, as does Highway Law, that the Town Board supervises and uses their auditing and their other authorities that they have over the Highway Department -- not only purse strings, but also supervisory authorities -- to monitor the operations of the Highway Department. This doesn't seem to be happening and I'm particularly, I'm particularly concerned that tonight we've discussed several issues of fairly grave import that concern operations of the Highway Department and the Highway Superintendent is absent. You've just discussed at length a repair proposal for a head gasket or whatever and this had to be voted down because he's not here to answer the many questions that you people had. I recall the last meeting there was again another

bid problem. Well, it wasn't a problem it was the purchase of a pickup truck and Mr. VanWormer managed to get only one single bid. Now I find that incredible especially in economic situation that we find ourselves now that he couldn't find two other vendors to provide bids for this thing and I'm further surprised that the Board approved that expenditure without instructing Mr. VanWormer to get out there and get several other bids at least to cover your own butts. I don't know, you know I don't know how this is working, but this is very, very odd to me. In my organizational experience this is very odd. We just closed an investigation on certain allegations made by members of this Board regarding falsified payroll documents. There are several other outstanding issues that involve not only state law but federal law. Such issues as the obstruction of government administration, official misconduct, misuse of position, personal use of government property, use of nonpublic information, use of nonpublic information which happens to be the information that was shared by the publishers of the allegations accusations made against the Highway Superintendent, and misuse of official time. All of these are going to be investigated. I just don't understand why the Town Board has not used it's authorities to monitor these situations and to correct them. I think I'm finished here.

Councilmember Downes: Well, let's just think about this. First of all if you had, wait you want answers...

Harold Vadney: Yes, I do.

Councilmember Downes: But you don't want to hear from us. That's the problem.

Harold Vadney: Oh, excuse me. I do want to hear from you.

Councilmember Downes: First of all they got three different bids and we told them they had to be closed bids because it was over amount. They sent it out for closed bid. The only company that put back in was DePaula. So he did get three bids and if you were here at that meeting you would have heard him say the three places and the dollar amounts.

Harold Vadney: That may very well be, but you voted on one...

Councilmember Downes: Okay, so don't say that we didn't try.

Harold Vadney: Okay, my mistake. I apologize for my inaccuracy then.

Councilmember Downes: That's number one.

Harold Vadney: However, you voted on one single bid right that was submitted.

Councilmember Downes: Because we had a closed bid. When the closed bid came in that was the only one.

Harold Vadney: You had one closed bid. You could have done the same thing then that you did tonight with this head gasket thingamajiggie here.

Councilmember Downes: Once again he had already gotten three different quotes. We told him because it was over the dollar amount it had to be a closed bid so it was put out, it was advertised for this truck. The other two people chose not to bid. That is nothing we can do. So that's number one. Number two these allegations that he has been absolved from. He did it, but because of the Town Board diligently checking time records, we found it so, therefore, it didn't get paid.

Harold Vadney: When it comes to you, okay, fine. You're sitting at the table up there. If you have a personal beef you should take it away from the council table...

Supervisor Ruso: Just as a matter of point, and Ms. Downes alluded to it, the errors in the payroll were discovered during audit and corrected so that did happen and so that's where that... That was a question.

Harold Vadney: Well there's a big difference between submitting falsified payroll documents and a misunderstanding.

Councilmember Downes: It wasn't a misunderstanding. He signed off on overtime that was ineligible. That is falsifying documents.

Harold Vadney: The investigation report that I read express an entirely different verbiage, okay. That is the verbiage I have from the Sheriff's Department, from the District Attorney. That's the language that I understand. You're telling me one thing. I read differently alright.

Supervisor Ruso: That's fine. So that was one issue. Does anyone else want to... Again, I don't want to keep interrupting.

Councilmember Downes: But it's a continual thing that gets brought up.

Supervisor Ruso: The one case was, I'll just describe one case. The Highway employees are supposed to get eight hours, all employees, maximum of eight hours of holiday pay. Yet when the holiday comes we put in for ten hours. Well, max is eight so on Fourth of July you get eight hours, but it was put in for 10. It was caught in the process and paid accordingly.

Harold Vadney: But, Mr. Ruso, certain members of this Board published accusations publicly available not only to this community, but it was nonpublic information, it was privileged information. The payroll statements about conduct of employees and payroll submissions...

Supervisor Ruso: I'm following up to your point about the Sheriff's Department's investigation. Any community events going on in the near future that anyone wants to bring up?

Ellie Alfeld: I remind you that the second week in October the Church luncheons start again and it's open to the public. It's a donation luncheon and all are welcome.

Supervisor Ruso: Do you know what's on the menu?

Ellie Alfeld: Roast Pork.

Jeff Etu: The entrance to the pavilion and to the baseball field needs to be addressed. Some of the senior citizens are having a problem. There's rocks that stick up.

Supervisor Ruso: We're looking at putting perhaps cement in.

Ellie Alfeld: Jeff and I discussed this at the picnic.

Supervisor Ruso: Rough ground.

Ellie Alfeld: It is, you can't get a wheelchair through.

Councilmember VanEtten: Yeah, that's a problem.

Ellie Alfeld: Anyway, if Alan has any leftover blacktop or screenings of the free...

Councilmember VanEtten: Milling.

Ellie Alfeld: Milling that they do.

Jeff Etu: It needs to be graded and leveled out properly so that...

Ellie Alfeld: Tampered down.

Jeff Etu: You don't have runoff going into the pavement, into the playground, or... I mean the baseball field looks great. Let's keep it that way. Let's start using these parks.

Supervisor Ruso: Well, we're gonna have to address that but I don't think it will be done before the end of... It will probably be springtime.

Harold Vadney: Oh, it is?

Supervisor Ruso: I think that one is. Most of them are owned by the Town, but there are still that remain. Chestnut over here on 9W.

Harold Vadney: Do we know who owns it so we can approach them?

Ellie Alfeld: Art Byas is the one to go to at one point.

Councilmember Boehlke: They have a committee, a Town-like. It's not a Town committee, it's a private committee.

Supervisor Ruso: A not-for-profit board.

Harold Vadney: I see. So Art Byas would be the man to contact.

Councilmember VanEtten: I think so. He was.

Supervisor Ruso: He has been very active with them.

Harold Vadney: I know his wife did a number of grants to restore that cemetery.

Supervisor Ruso: He's been very active with them so I can't say he still is.

Harold Vadney: Okay, fine. I thought it was a Town cemetery.

Supervisor Ruso: No, it's not. Not yet. It it's abandoned, then it becomes a Town cemetery and we get to take care of it.

Harold Vadney: I see.
